- A. MISSION STATEMENT, STRATEGIC OBJECTIVES, GOALS, AND PERFORMANCE METRICS**

Legal Services

Our mission is to provide excellent legal services to the State of Hawai'i by providing advice and counsel to client agencies, assisting in implementing policy decisions, and aiding the core activities of client agencies. Carrying out this mission includes (1) initiating lawsuits to protect the interests of consumers and the public, and appearing for the State in civil and criminal cases when the State is a party; (2) investigating violations of state laws, enforcing the laws, and prosecuting those who violate the law; (3) preparing legal opinions for the Governor, Legislature, and the heads of state departments; (4) advising state officials, including more than 170 boards and commissions, on legal matters so they can faithfully execute their duties and responsibilities; (5) defending and representing state officials and employees when they are sued for actions that have occurred as part of their official duties; and (6) collaborating with other states as well as federal and local counterparts on matters of importance to our State.

Our strategic objectives are to continue to improve and maintain an environment that attracts and nurtures talented attorneys with a commitment to public service, so that our Department can continue to represent the state successfully at the local and national level on a myriad of matters.

Our immediate goals are to:

1. Identify areas where the Department's younger or less experienced deputies require training and mentorship and identify internal and external resources that will assist in providing the necessary training.
2. Continue to develop and implement successful succession planning by providing leadership training and mentorship to deputies who have the potential and desire to assume supervisory and leadership positions within the Department.
3. Continue to improve the legal Department's relationship with the Legislature through timely and effective communication.

Some of our performance metrics rarely change because they are so closely tied to successful representation of our clients. If we do our job well, we save money and resources for the State. We are developing specific goals and objectives relating to the Department's interactions with and legal advice to different client agencies such as boards and commissions. This will be an ongoing project.

Crime Prevention and Justice Assistance Division

The Crime Prevention and Justice Assistance Division (CPJA) assists the Attorney General by facilitating and coordinating efforts to improve the criminal justice system and to encourage community partnerships in addressing crime. Its operations are encompassed in ATG100 Legal Services, and funding concerns related to it are addressed in Section D, below. CPJA provides subject matter expertise and administrative services involved with the Department's responsibilities as Chair of the Firearm Crisis Intervention Advisory Board, Governor's Committee on Crime, and the Violence Against Women Act State Planning Committee. Within CPJA is the Missing Child Center – Hawai'i, which is the State's missing children clearinghouse and is a resource center for law enforcement, social services, and families of missing children. The Grants and Planning Branch identifies, applies for, and administers federal crime and crime prevention funding, much of which is distributed to the counties. Also, within CPJA is the Community and Crime Prevention Branch, which is responsible for planning and implementation of informational and educational presentations and activities in areas such as alcohol, tobacco, and other drug and community crime prevention, e.g., Celebrate Safe Communities, and online safety for youth.

Hawai'i Criminal Justice Data Center (HCJDC)

The mission of the HCJDC is to provide complete, accurate, and timely criminal justice information for use by all criminal justice agencies, as well as certain authorized non-criminal justice agencies, throughout the State. HCJDC's mission is accomplished by providing a statewide system of civil and criminal identification based on fingerprints

and demographics.

The HCJDC is statutorily mandated to collect, store, and disseminate all criminal justice data to be used nationally by criminal justice agencies as a tool "to prevent crimes and detect criminals in support of the right of the public to be free from crime and the fear of crime." Section 846-2.5, Hawai'i Revised Statutes (HRS). Criminal history data serves as a critical tool in determining dangerousness during arrests and during initial court appearances to ensure appropriate custody status is maintained (including bail) as well as fair sentencing. HCJDC provides 24x7 on-call services to law enforcement and criminal justice agencies to respond to system issues for both State and Federal criminal justice systems.

HCJDC works closely with each counties' police departments and prosecutors, and the Judiciary to continually upgrade, integrate, and trouble shoot data sharing that is critical to the law enforcement agencies.

Child Support Enforcement Agency (CSEA)

The objective of the CSEA is to provide assistance in obtaining support (both financial and medical) for children by locating parents, establishing paternity, establishing support obligations, and enforcing those obligations. CSEA is heavily regulated by the federal government and recently upgraded its online services to increase efficiency and customer satisfaction.

B. HOW CURRENT STATEWIDE ECONOMIC AND FISCAL CONDITIONS HAVE AFFECTED OPERATIONS AND THE ABILITY TO MEET GOALS

Legal Services

The Department is working closely with client agencies and their staff to properly comply with all laws to reduce litigation. We recognize that certain compromises have and will need to be made but will work to ensure that our core function, providing solid legal advice and support, will not be jeopardized.

Due to the generous appropriation for salary adjustments made by the Legislature for fiscal year 2023 to increase deputy attorneys general salaries, the Department's ability to compete with the City and County of Honolulu and the private sector in recruiting and retaining talented attorneys has increased substantially. Although we will continue to have vacancies, as many of our deputies are eligible to retire and are retiring, the Department's ability to offer competitive compensation and benefits commensurate with an applicant's experience means that vacancies can and will be filled more quickly.

The Department continues to face workforce challenges, finding it particularly difficult to recruit and hire for our non-attorney positions, namely our civil service legal

assistants, legal secretaries, legal clerks, and office assistants. Some positions have been vacant for 24 months or more despite active efforts to recruit. Without support from our civil service employees, other employees, including deputies, are carrying the work for those divisions with vacancies and end up spending time on administrative work that takes time away from their ability to provide services to our clients. We are developing internal workforce training, which we have had some success with. This process, however, requires additional time and attention from deputies and staff that are already overworked.

Another external factor expected to significantly impact the Department's operations and resources involves the recent unilateral decision by the Department of the Prosecuting Attorney for the City and County of Honolulu (Honolulu Prosecuting Attorney) to no longer prosecute criminal cases arising from arrests by State law enforcement agencies. As a result, the Department's Criminal Justice Division (CJD) has had to absorb these cases. Additionally, the Honolulu Prosecuting Attorney has informed the Department that it will no longer be handling bail forfeiture cases. Upholding the law is a joint responsibility best achieved through collaboration between the State and the counties. The unilateral decisions by the Honolulu Prosecuting Attorney to offload previously performed duties and dismiss attempts by the Department to reach mutually agreeable solutions to these issues is unfortunate. Nonetheless, the Department intends to fulfill its public safety obligations from our existing resources, vigorously recruit to fill position vacancies within CJD, explore options for internal reorganization, and ultimately assess the impacts of the increased workload on the Department before deciding whether additional resources are needed in the future.

Finally, the recent devastating Maui wildfires has necessitated the need for the Department to contract for outside expert legal counsel in certain areas of law to protect the State and public interest. As announced in August, the Department also retained the services of the independent third-party Fire Safety Research Institute to investigate government actions before, during, and following the fires; the investigation remains ongoing. Despite the financial cost, these contracts are critical. Thankfully, due to swift action by the Administration, a sizable portion of these legal costs are being funded from unexpended ARPA – CSFRF funds. While the Department's regular operating budget is absorbing some Maui wildfire related costs, as our budget currently exists, we believe that we will weather the current financial conditions caused by the wildfires without requiring an emergency appropriation. The Department has reprioritized its budget for the current fiscal year and will carefully monitor its expenditures. We will also be requesting the release of the general fund restrictions levied on the Department for the fiscal year. It should be noted that in response to the Maui wildfires the Department has dedicated a significant amount of time to advising client agencies, writing, reviewing, and finalizing emergency proclamations, and meeting with stakeholders, in addition to our regular work.

Hawai'i Criminal Justice Data Center (HCJDC)

HCJDC's overall yearly budget is covered 34.64% by general funds. The remaining 65.36% of HCJDC's budget is funded using revolving funds from the Criminal History Record Improvement Revolving Fund established by Section 846-10.6, HRS (Account No. S-321). The S-321 account funds 25.50 of the 49.00 positions that are essential to the operations of HCJDC, and the purchase of maintenance, consultants, and hardware not budgeted for in HCJDC's general fund allocation. Without special funds, HCJDC will not be able to continue to support the State's mission-critical criminal justice systems, which require 24x7 on-call services to law enforcement and criminal justice agencies. This is a high priority for the HCJDC and all such agencies that depend upon these criminal justice services to maintain public safety for the State of Hawai'i.

HCJDC is responsible for the daily operations, upkeep and maintenance of (1) the Criminal Justice Information System (CJIS)-Hawai'i, (2) the statewide Automated Biometric (ABIS) and facial recognition system, (3) the statewide system/database of booking information (otherwise known as the Green Box System), (4) the Lights-Out Transaction Controller (LOTIC) which ties together these systems in the real-time positive identification process, and (5) the Hawai'i Integrated Justice Information Sharing (HIJIS) program, which is a portal to share Hawai'i criminal justice information by single logon and query and connectivity to the FBI's Criminal Justice Information Services (CJIS), which includes the National Crime Information Center (NCIC), National Instant Criminal Background Check System (NICS), National Data Exchange (N-Dex), and the Law Enforcement Enterprise Portal (LEEP). In addition to the above systems, HCJDC is responsible for public access to Criminal History Records, expungements, and the Covered Offender Registry.

Child Support Enforcement Agency (CSEA)

For fiscal year 2023, CSEA managed approximately 87,000 cases and collected over \$103 million in child support payments. These collections went to supporting children and providing families critical resources. CSEA receives 66% of its funding from the federal government. For every \$1 the agency receives from the state general fund, \$2 is received from the federal government. Any budget restriction to CSEA's general fund appropriation reduces the agency's available funds by three times the amount. This impacts CSEA's ability to fill vacancies, maintain its quality of customer service and provide critical resources to families.

In addition, CSEA, in partnership with the Federal Office of Child Support Enforcement, is committed to improving its operations according to federal performance effectiveness measures. The categories to show performance effectiveness are (1) percentage of children born out of wedlock where paternity is established, (2) percentage of cases with a child support order, (3) level of performance in collecting current support, (4) level of performance in collecting arrearage, and (5) cost-effectiveness of the program.

The CSEA is awarded federal incentive money every federal fiscal year based on its performance in these categories after an annual data reliability audit. The incentive funds are used to supplement, but not to supplant, the agency's general and federal funding sources for operational purposes.

C. FEDERAL FUNDS

Legal Divisions

No current impact.

Crime Prevention and Justice Assistance Division

Federal agency: U.S. Department of Justice, Office of Justice Programs, Office for Victims of Crime Federal program at risk of reduction of federal funds: Victims of Crime Act (VOCA) Victim Assistance Grant CFDA: 16.575

There has been a steady decline in federal funds received for the Victims of Crime Act (VOCA) Victim Assistance Grant. The Department's Victim Assistance grant amount in federal fiscal year (FFY) 2018 was \$14,803,390; in FFY 2019, the grant amount was \$10,058,537; in FFY 2020, the grant amount was \$7,502,120; in FFY 2021, the grant amount was \$4,783,838; in FFY 2022, the grant amount was \$6,547,786; and, in FFY 2023, the grant amount is \$6,156,448.

For FY 2024, the State provided a supplemental allocation to the Victim Witness Assistance (VW) Program raising the state funding from \$401,078 to \$1,776,093. The Department administers the VW program and the supplemental request included positions at the county prosecutor offices that support a statewide victim witness assistance program. The County prosecutor offices sustain their respective Victim Witness units with a combination of federal, state, and county funds. The State relies on the counties to provide specialized services to victims/witnesses of violent crimes who are going through the criminal justice system. These crimes include assaults, sexual assaults, terroristic threatening, kidnapping, reckless endangering, spouse/partner abuse, child abuse, and elder abuse. The services include crisis counseling, information on the criminal justice system, assistance filing criminal complaints, court accompaniment, social services referrals, and applications for Crime Victim Compensation. The Department is submitting a supplemental budget request for FY 2025 to maintain funding at \$1,776,093 for the VW program.

It is unclear when the federal reductions will slow or reverse.

Background: In 1984, the federal Victims of Crime Act (VOCA) was passed establishing the Crime Victims Fund (CVF) to assist and compensate victims and survivors of crime. The CVF comprises federal criminal fines, forfeited bonds, forfeited profits from criminal

activity, additional special assessments, and donations by private parties. Congress disburses money from the CVF in the annual appropriations process, and the Office for Victims of Crime (OVC) oversees the fund and distributes the money in the form of formula grants to states and territories. The Department administers the Victim Assistance grant program (CFDA 16.575), and sub awards the fund to victim services for victims of all crimes including crimes such as murder and drunk driving, with a statutory priority for child abuse, domestic violence, and sexual violence services. Over the past several years, deposits to the CVF have decreased dramatically. As the amount of money available in the CVF has dwindled, so has the money available for VOCA grants to the states. Appropriators wrote in 2019, "The Committee is concerned . . . by the historically low receipts deposited in the CVF, and in turn, the decrease in resources available for OVC's disbursement of CVF funded grants and cooperative agreements." After a watershed disbursement from the CVF in Fiscal Year 2018, disbursements have decreased annually. Accounting for transfers, the disbursement in Fiscal Year 2020 was 40% lower than it was in Fiscal Year 2018. In July 2021, President Biden signed the Sustain the Crime Victims Fund Act of 2021 to stabilize the Crime Victims Fund and provide enhanced support to survivors and victim-centered programs.

The Sustain the Crime Victims Fund Act of 2021 (VOCA Fix) enacted in July 2021 by President Biden permits the VOCA Victim Assistance Grant to allow state administering agencies a no-cost extension of up to one year per grant award to provide states with additional time to re-purpose or use available Victim Assistance funds that otherwise would lapse back to OVC. The VOCA fix also expanded Crime Victim Fund deposits to include non-prosecution and deferred prosecution cases which is reflecting some immediate impact. As of October 31, 2023, the amounts received from deferred prosecution and non-prosecution agreements in 2021, 2022, 2023, and 2024 were \$225 million, \$531 million, \$264 million, and \$113 million respectively.

Hawai'i Criminal Justice Data Center (HCJDC)

No current impact.

Child Support Enforcement Agency (CSEA)

Federal Funds continue to be available at a match rate of 66% federal to 34% state funds. This is a 2:1 match rate, one of the best offered to fund entitlement programs. In general, federal funds are available to match all state funds appropriated without limit. The agency is under strict federal regulations that require all personnel and other expenditures be completely related to child support activities. If this requirement is not met the federal government will not provide the matching funds.

E. PROCESS TO DEVELOP AND PRIORITIZE BUDGET REQUESTS

The Department was careful when developing and prioritizing its budget, bearing in mind the State’s overall fiscal condition against the backdrop of the wildfires that occurred on Maui and Hawai’i Island. As such, we focused our budget requests on those items deemed essential to our operations.

Division supervisors were asked to identify areas of need within their division operations and to submit these requests to the Administrative Services Manager (ASM) for initial review. These requests were carefully assessed to first determine whether existing resources were sufficient or could otherwise be reallocated to meet those areas of need. Requests that were determined to require budgetary action to provide additional resources or legislative authorization were calculated and formalized on Form As by the ASM in collaboration with the division supervisors. Where appropriate, the ASM held meetings with each division supervisor that submitted a budget request to discuss in greater detail the need for the budget request, the budget process, and how the request advances the Department’s mission and purpose.

These Form A requests were then reviewed and prioritized by the Attorney General (AG), the First Deputy Attorney General (FDAG), and the ASM. At this stage, requests were either approved as is, amended, or deferred. Requests that were determined by the AG, FDAG, and ASM to be critical to the Department’s operations in fulfilling its statutory obligations were submitted to the Department of Budget and Finance for their review and recommendations to the Governor.

F. HOW SIGNIFICANT BUDGET REQUESTS ARE EXPECTED TO AFFECT OUTCOMES

Legal Division

1. Add 3.00 permanent FTE positions and \$248,568 of general funds to restore positions and funds for the ATG Investigations Division.

Act 278, SLH 2022, established the Department of Law Enforcement (DLE) and provided for the transfer of 21.00 FTE positions to be transferred from the Department of the Attorney General (ATG) to the DLE. These positions include 18.00 Investigators, 1.00 Chief Special Investigator, 1.00 Investigator VI, and 1.00 Secretary III.

The Investigations Division of ATG will continue to exist and be required to perform administrative investigations and other investigative functions required by statute and assigned to ATG. Maintaining a stable continuity of operations will require leadership positions and administrative support. It is important to provide the division with a Chief Special Investigator to lead the division, an Investigator VI to serve as a working supervisor, and a Secretary III to provide administrative support.

This request will affect outcomes by ensuring that the day-to-day operations of investigations conducted by ATG are effectively managed. The leadership positions are directly responsible for the delegation of investigative assignments, managing division personnel, and performing administrative tasks.

2. Add \$2,456,750 of general funds for the Career Criminal and Victim Witness Assistance Programs.

Both the Career Criminal Prosecution (CCP) and Victim Witness (VW) Assistance programs are State programs implemented primarily by the counties. The counties provide specialized services to victims/witnesses of violent crimes who are going through the criminal justice system. These crimes include assaults, sexual assaults, terroristic threatening, kidnapping, reckless endangering, spouse/partner abuse, child abuse, and elder abuse. The services include crisis counseling, information on the criminal justice system, assistance filing criminal complaints, court accompaniment, social services referrals, and applications for Crime Victim Compensation.

These programs provide important direct community support for prosecuting repeat criminal offenders and providing support services for crime victims and witnesses. Without State financial support and the assistance of the counties to administer these programs, the capacity to prosecute career criminals and provide crime victim and witness support services would have to be scaled back and would be severely limited.

3. Add 4.00 permanent FTE positions and \$462,134 of general funds for the Hawai'i Correctional System Oversight Commission (HCSOC).

The HCSOC established itself in 2022 and is governed by Chapter 353L, HRS. The mission of the HCSOC is to standardize responsible efficient, and transformative oversight practices for the State's correctional system.

A request to enfold the HCSOC into ATG's operating budget was presented to the 2023 Legislature but was not funded. For fiscal year 2024 the Governor provided \$413,388 to the HCSOC for its operations pursuant to Section 5 of Act 164, SLH, 2023. The HCSOC has again submitted a request to include its

operating costs in the executive budget to ensure operational continuity and stability into future years.

Funding the HCSOC directly impacts the agency's ability to achieve its desired outcomes as a lack of funding would mean that the HCSOC would be unable to conduct correctional facility inspections, issue reports, and otherwise work to make recommendations for correctional system improvements.

POSITION ORGANIZATION CHART



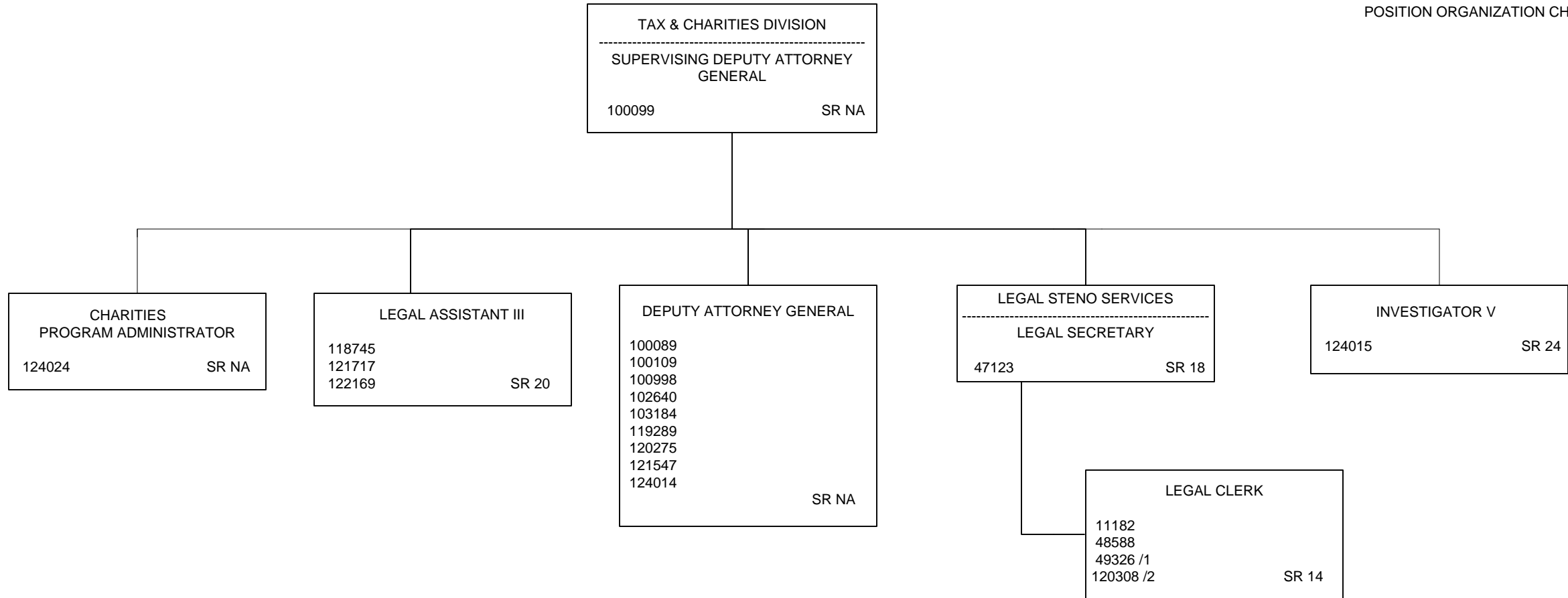

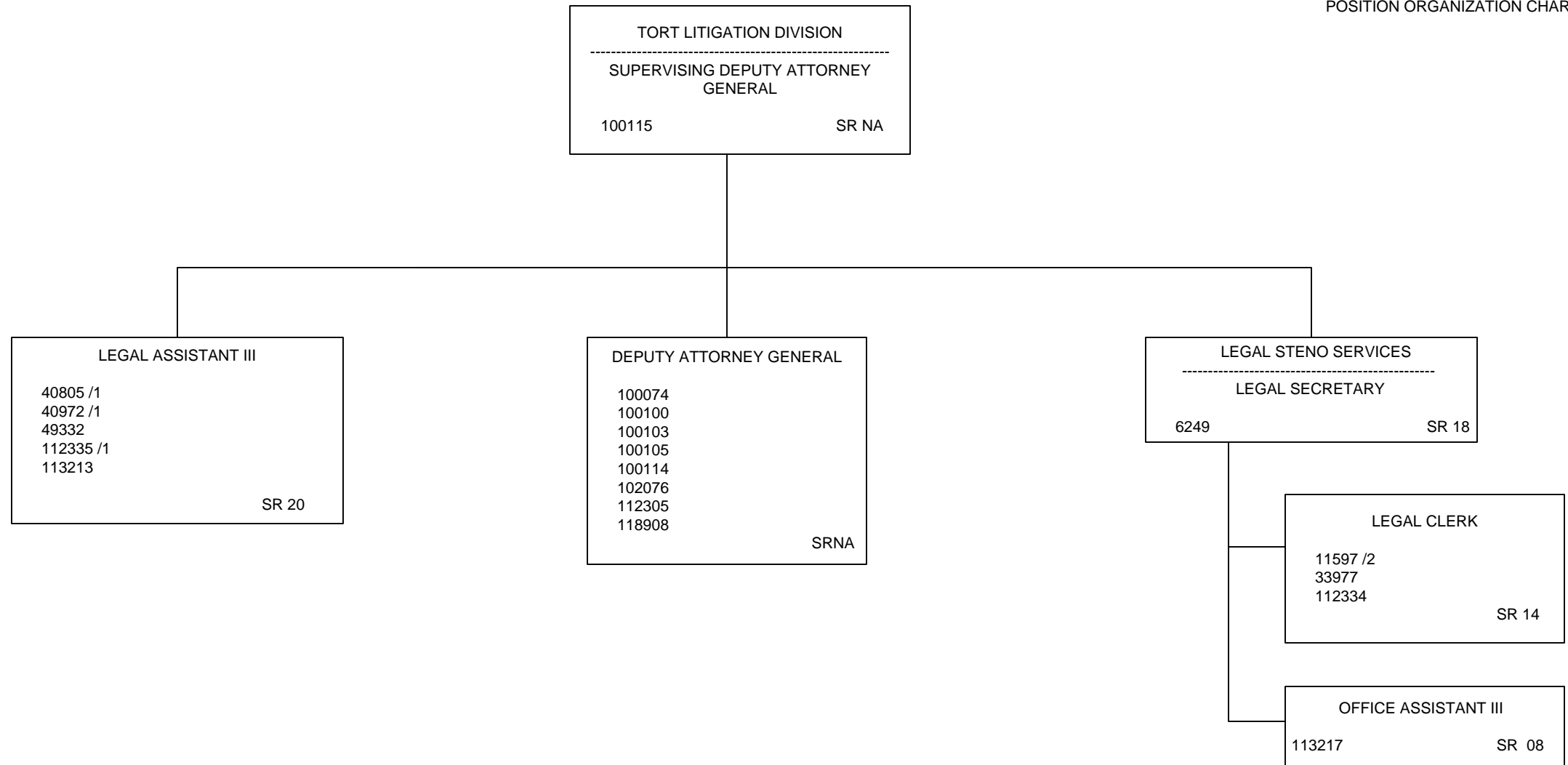
