In Consideration of the Executive Biennium Budget for Fiscal Biennium 2025–2027

Chair Yamashita:

In response to your request of December 6, 2024, the Office of the Governor has two operating budget requests for the 2025–2027 Fiscal Biennium (FB) Budget. The requests are as follows: (1) to add 6.00 permanent positions and \$725,000 for federal affairs and boards and commissions positions, and (2) the transfer-out of 6.00 permanent positions and \$470,000 for the Office of Wellness and Resilience (OWR) as part of the transition of OWR to a principal department.

The request for positions and funds for federal affairs includes 3.00 permanent positions to be based in Washington, D.C., and 2.00 permanent positions in Hawai'i. It is important that the State of Hawai'i have staff in Washington, D.C. with direct ties to Hawai'i to stay abreast changes to federal regulations, funding opportunities, and to meet frequently with federal officials. Additionally, the Office of the Governor is requesting 1.00 Boards and Commissions Specialist to support statewide coordination for more than 170 boards and commissions and to service over 1,400 state residents who are serving diligently.

Act 291, SLH 2022, created OWR, which is the nation's first statewide-legislated Office of Wellness and Resilience. OWR is focused on strengthening our state systems and services using healing-centered principles as strategies to make Hawai'i a trauma-informed state. OWR was

established in the Office of the Governor for fiscal years 2024 and 2025 and is scheduled to transfer to the Department of Human Services (DHS) in fiscal year 2026. OWR has had discussions with DHS and Department of Human Resources Development (DHRD) and found that DHRD has many synergies for OWR projects. As such, OWR will submit a bill with the proper amendments to facilitate this change.

We are committed to continuing the ongoing recovery efforts from the Maui wildfires, the worst natural disaster in the State's history, including continued mental health support, temporary housing and a new elementary school. This tragedy continues to serve as a powerful reminder of the importance of community, compassion and solidarity. We believe that with the Legislature, our community partners, other sectors of government and the private sector, we can improve the lives of Hawai'i's people. We have made significant progress with the support of the Legislature, with the enactment of these historic tax measures which provide much needed direct relief for working families in our state.

We remain open and accessible to the Legislature and the general public. We appreciate your continued support in our efforts to address the state's highest priorities.
