2	Fifth Circuit	Pu'uhonua Kaulike – Replace an A/C chiller that is near the end of its lifecycle, while A/C manufacturing hardships result in long lead times.	\$0.9M
3	Administration	Lump Sum CIP (Bond Funds) – Continue long-term improvements, renovations, and upgrades to extend the life of facilities occupied by the Judiciary statewide.	\$5M
