DEPARTMENT OF HEALTH SOIL DATA

The Department of Health "DOH" received test results from soil samples collected from the Red Hill Bulk Fuel Storage Facility where over a thousand gallons of aqueous film foaming foam were released in November. LEGISLATIVE PRIORITIES

HB 948 Establishes a two-year child and adolescent crisis mobile outreach team pilot program on Oahu to expand existing crisis response services.

HB 949 Establishes solar energy storage system loan program. Establishes and appropriates funds for a renewable energy system installation loan program.

HB 950 Extends the time period that a family court may order continued assisted community treatment. Reduces the time period that a family court needs to determine whether assisted community treatment should continue.

HB 951 Deposits funds into the rental housing revolving fund to be used to provide grants or loans to mixed-income rental projects or units qualifying individuals and families.

HB 952 Appropriates funds to the Department of Land and Natural Resources "DLNR" to address the impacts of climate change in the State.

HB 953 Requires DLNR to develop and publish a website that includes the application processes for a permit, license, or reservation needed to conduct recreational and commercial activities in the State that are regulated by or under the jurisdiction of the department.

HB 954 Changes the amount of the state earned income tax credit to an unspecified percentage of the federal earned income tax credit allowed based on an individual's federal income tax return.





BILLS BEING INTRODUCED BY REPRESENTATIVE AIU

HB 543 Establishes an income tax credit for taxpayers who purchase and install a whole house water filter system.

HB 814 Requires the counties to allow religious institutions, educational institutions, and medical institutions to build housing units on land that the institutions own for purchase or use by the institutions, their employees, or their contractors.

HB 816 Clarifies the deadline for submitting written protests that are based on the content of a solicitation.

HB 1297 Requires registration for condominium associations to be on an annual basis, rather than on a biennial basis. Adds an additional annual condominium education trust fund fee to be used to support the annual registration with attached documents of the association.

HB 1298 Prohibits the use of proxies in condominium association voting. Requires associations to allow members to vote by mail and attend and cast votes in association meetings through internet, teleconference, or other electronic transmission technology. Requires associations to mail out paper ballots before any annual or other periodic election of board members.
