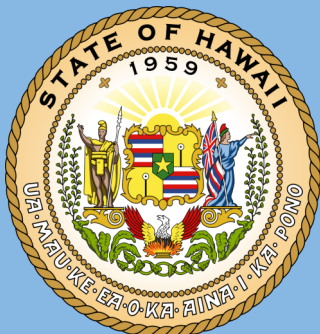

Aloha Neighbors,

In the aftermath of the Lāhainā wildfires, the Hawai'i House of Representatives has formed six interim working groups to identify and evaluate the necessary solutions to help Maui recover as well as mitigate the risks of something like this from happening again. Each working group will have the responsibility of evaluating specific topics and providing recommendations for appropriate legislative action in the 2024 legislative session.

The topics that these groups will be focused on are (1) **Environmental Remediation**, to evaluate the cleanup of ground and ocean contamination, including the timeframe and techniques utilized. (2) **Food, Water and Other Supplies**, to evaluate the availability and distribution of food and other necessary supplies for displaced individuals and families. (3) **Jobs and Business**, to evaluate the strategies utilized to accommodate displaced students and staff to return to school. (4) **Schools**, to evaluate the strategies utilized to accommodate displaced students and staff to return to school. (5) **Shelter**, to evaluate the availability and creation of temporary and transitional shelters for displaced individuals and families. And (6) **Wildfire Prevention**, to identify the causes of wildfires and preventative action that may be taken to reduce the risk of wildfires throughout the state.

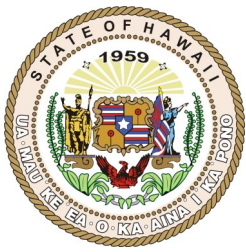
After some initial planning and collaboration with federal, state, and county agencies, the House will hold public hearings on the substantive recommendations of each working group.
