

Board of Water Supply Update

The Board of Water Supply (BWS) has scheduled the design of a service lateral replacement project in the Waiau area to enhance water service reliability. ControlPoint Surveying, Inc. has been contracted to conduct surveys of streets, sidewalks, and water meter areas to gather necessary data. Construction will follow the completion of design work and approval processes.

BWS has said they will notify residents before work begins and our office will continue to monitor progress and provide updates as we receive them. Some of these updates may come in the form of the above mentioned digital newsletter.
