HB541: Relating to Urban Development

Exempts Oahu from Act 39, SLH 2024 which authorized at least 2 ADUs on residential properties.

HB548: Relating to St. Francis

Authorizes UH to issue revenue bonds to purchase the former Saint Francis school site.

HB542: Relating to the Hawaii Promise Program

Expands the Hawaii Promise Program to provide scholarships for the unmet needs of qualified students at any 4-year UH campus.

HB547: Relating to the Spaying and Neutering of Animals

Establishes the Spay and Neuter special fund to reduce pet overpopulation with various revenue and fundraising sources.

HB441: Relating to Cigarette Taxes

Increases taxes on cigarettes and allocates those funds to the Hawaii Cancer Research Special Fund.

HB1384: Relating to A.I.

Establishes an Artificial Intelligence (AI) advisory council and requires a comprehensive action plan.

HB188: Relating to CIP for District 22

Appropriates funds in the FY26-27 budget for the following:

- Noelani Elementary: \$5.5M for a new portable building.
- **Mānoa Elementary**: **\$550k** for perimeter fencing.
- Hōkūlani Elementary: \$275k for a shade structure.
- **Mānoa Library**: **\$330k** to replace the elevator.
- **UH Mānoa**: **\$6.5M** to demolish Hale Noelani dormitory and **\$9M** in design/planning funds for parking structure on upper campus.

Mānoa Banyan Court Files Final Environmental Assessment (FEA)

Lin Yee Chung Association (owners of the Mānoa Chinese Cemetery), recently filed an FEA for its Mānoa Banyan Court project. Over 1,400 pages of public comments were submitted to the City Department of Planning and Permitting on LYCA's plans to build affordable housing for seniors on an adjacent lot to the cemetery. It is unclear when the Honolulu City Council (not the State Legislature) will vote to approve or deny the project.
