Bills and Resolutions for 2025

Here are some legislative proposals I'm working on in the 2025 Legislative Session.

Pharmacy Workforce Development

To develop workforce development initiatives for local pharmacists, this bill will establish a special fund for the University of Hawai'i's School of Pharmacy. Similar funds have proven effective for UH's medical and nursing schools in their efforts to attract and retain local talent for these specialties.

Mandatory Moped Insurance

The legislation to mandate moped insurance and helmet use aims to protect riders and reduce the risk of severe injuries. By requiring insurance, we can provide financial protection for all parties involved in accidents. Enforcing helmet safety will significantly decrease the likelihood of life-threatening head injuries.

Paid Family Leave

The Paid Family Leave legislation aims to create a state program that provides partial wage replacement for employees caring for family members. This initiative is crucial for families facing medical or caregiving challenges, ensuring they don't have to choose between their job and their loved ones. Recognizing the high cost of living in Hawai'i, Rep. Sayama is committed to working with employers and employees to ensure this program provides meaningful support for all working families.

Addressing Squatting

Addressing the issue of squatters is vital for the well-being of our community. The first bill establishes a collaborative group representing various agencies to streamline the eviction process of squatters, ensuring a more efficient and coordinated approach. The second bill aims to hold squatters accountable for any home damages and utility costs incurred during their occupancy.

Feral Chicken Removal

Following the recommendations of a State and City and County of Honolulu Working Group, this bill would appropriate funds to the City to implement a feral chicken removal service. This will address concerns from neighbors regarding noise, health hazards, and threats to native species.

Free rain garden, trees, or rain barrel installations are available to O'ahu residents for a limited time (applications close March 31). The non-profit *Hawai'i Green Growth* helps identify rain saving opportunities.

- What is the purpose? This project is to recharge our aquifers and to mitigate flooding and brown water runoff flowing into nearshore marine habitats. Rain gardens and other "green stormwater infrastructure" (GSI) are effective ways of achieving this by keeping rainwater where it falls.
- Rainwater capture projects are a cost-effective way for residents to protect O'ahu's precious groundwater, mitigate stormwater pollution in streams and the ocean, and potentially soak up savings on water bills!
