THE LEGISLATURE ' S

FIRST PRIORITY AND GREAT CHALLENGE WILL BE TO PRESERVE ESSENTIAL SERVICES FOR THE PUBLIC WHILE BALANCING THE STATE BUDGET, AS REQUIRED вY LAW.

The State Budget (HB 200)

The House passed a budget bill that cuts approximately \$120 million in each year of the biennium from the administration's budget plan, with the greatest amounts coming from state agencies with the largest budgets – education, higher education, health and human services. This bill now goes to the Senate for review.

The House draft of the State Budget represents about a 10.2% growth from the FY11 base budget. This is a decrease from the budget proposed by the Abercrombie administration, which represented a 15.3% growth from FY 11.

Much of the increase is due the cost of ending furloughs for state workers which, under present collective bargaining agreements, are set to end on June 30, 2011. If the Governor achieves salary savings in new collective bargaining agreements, the Finance committee will make adjustments to the budget accordingly.

While no one wants to raise fees and taxes, the House's revenue generating measures are aimed at protecting low to middle income residents who can least afford higher expenses. If passed, these bills will generate an estimated \$300 million per year.

Pension Income Tax (HB1092)

Hawaii remains one of a handful of states that does not tax pension income. This bill proposes to apply income tax on those who have a federal adjusted gross income of \$200,000 if filing jointly or as a surviving spouse, \$150,000 if filing as a head of household, and over \$100,000 if filing individually. The threshold of the pension income is very high and will affect less than 1% of all Hawaii tax filers.

Mortgage Foreclosure Moratorium (HB894, HD1)

Hawaii homeowners are facing monumental problems with mortgage foreclosures, an issue impacting many areas across the country. As a temporary "timeout", this bill establishes a five month moratorium on non-judicial foreclosures only, so that homeowners can be protected from lender violations while the legislature and industry review the consumer protection statutes and foreclosure laws.

Non-judicial Mortgage Foreclosure Process (HB1411, HD2)

This bill improves the nonjudicial mortgage foreclosure process. It protects homeowners facing foreclosures from possible lender abuse by establishing a new system for nonjudicial mortgage foreclosures and mandatory mortgage foreclosure dispute resolution at the election of the homeowner.

Cutting Government Spending

Saving Medicaid funds (HB 561, HD 1)

Requires Medicaid vendors to notify the Department of Human Services when Medicaid enrollees are also covered by private health insurance plans. The intent is to save Medicaid funds by designating the private insurance as "primary." This designation effectively requires the private insurance to be the first payer of the health care cost of the enrollee rather than Medicaid.

Revisions to the public employees' retirement system (HB 1038, HD 2)

Makes comprehensive revisions to the public employees' retirement system for new public employees (those hired after June 30, 2012). This bill is intended to limit the unfunded liability of the system, the amount owed to future retirees, and to moderate the annual contribution by the State to pay for future retirement benefits.

Salary cuts (HB 575, HD 1)

Extends the 5% salary decrease for legislators, elected and appointed executive branch officers, and justices and judges.

Improving Healthcare

Health benefit exchange (HB 1201, HD 1)

Establishes the Hawaii health benefit exchange in compliance with the federal health care law. The intent of the exchange is to increase competition among health insurance plans by providing consumers with comprehensive information about plans available on the market.

Prepaid Health Care Act (HB 1134, HD 1)

Amends Hawaii's Prepaid Health Care Act to ensure preservation after the federal health care law takes effect. In effect since 1974, Hawaii's Prepaid Health Care Act provides better benefits than the federal law and is accepted as a part of life and business in Hawaii.

Appointed School Board (SB8, SD1, HD2)

In November 2010, voters ratified a constitutional amendment changing the Board of Education from an elected board to one appointed by the Governor with the advice and consent of the Senate. This bill allows the Governor to directly nominate candidates but requires that they meet certain qualifications.

facilities get older, the Department of Education has been considering the future of certain schools to better meet the educational needs of school districts. This bill establishes a way to generate income to construct. repair and retrofit public schools to meet current and future needs. All public school lands would be transferred into the Trust, and a Public School Lands Trust Commission would be established within the Department of Land and Natural Resources to manage, administer and control the Trust.

Domestic violence penalties (HB 1003, HD 2)

Provides greater protection for domestic violence victims by enhancing penalties when such victims are harmed or threatened by their abusers.

Promoting Public Safety

Disaster Preparedness (HB 314, HD 1)

Establishes the office of disaster preparedness and a disaster preparedness commission to develop a disaster preparedness plan, including an identification of natural hazard zones in the State.



Ignition Interlock/ Drunk Driving (HB 1435, HD 2)

Enacts amendments to the Hawaii ignition interlock law which imposes restrictions on persons convicted of driving under the influence.

This law shall take effect on... January 1, 2050!?

Don't panic if you see what looks like a crazy date at the end of a bill. Often legislators will amend a bill's effective date to a so-called "**defective date**." It's an effective date that is far in the future and is inserted as a "**placeholder**" to ensure that there will be further discussion on the measure. Although not intended to be enacted with this far future date in place, if it does pass, it would not render the measure invalid – it would simply prevent the measure from taking effect for a long time.
