# Why is the Price of Condo Insurance Increasing?

Hawaii is now facing the financial impact of climate change. Many of us are paying more for HO6 and condo insurance. This is largely due to increased hurricane, wildfire, and water leak risks.

Hawaii has only 3 condo insurance carriers, and the natural disaster risk has led to higher premiums. Some condo buildings are not fully insured. A building that is underinsured may not meet federal lending requirements and may prevent lenders from providing mortgages and loans for units within the building.

Other states such as Florida and California are experiencing the same conditions. Like those states, Hawaii cannot require an insurance company to continue to operate in the state or to lower premiums. The Legislature is working on proposals to potentially stabilize the insurance market.

House Bill 2686 and Senate Bill 3234 propose to create a fund that can provide stopgap coverage for underinsured buildings as a last resort. House Bill 2801 proposes to create an alternative and more economical financing mechanism for buildings that require major repairs and preventative action, especially for water pipe replacement. Rep. Saiki joined by Sen. Sharon Moriwaki, Rep. Adrian Tam, and Rep. Scott Nishimoto recently held a town hall to discuss condo insurance. The panel was comprised of experts from the insurance, lending, and association industries. # First of Its Kind Homeless Health Crisis Center Opens in Iwilei

Rep. Saiki attended the opening of the Behavioral Health Crisis Center which will provide medical, mental health, and shelter services for homeless individuals. The triage center is located at the lwilei Resource Center next to I.H.S., where first responders can divert persons there for treatment. The City owns the building, and the Legislature funded \$6.7 million for staffing and operations. The center can accommodate 16 individuals in initial crisis with an additional nine stabilization beds. Pioneering in its approach, this center by the Department of Health addresses a crucial gap in crisis care. It not only diverts individuals from arrest to care but also eases the strain on community emergency departments, ensuring taxpayer money is put to efficient use.





# Solidifying Same Sex Marriage Rights

At the height of the same-sex marriage lawsuit in Hawaii in 1998, Hawaii voters approved a constitutional amendment to prevent the Hawaii courts from deciding whether same sex marriage is constitutionally protected. This meant that Hawaii law prohibiting same sex marriage would remain in effect. But in 2013, the Legislature amended the law to authorize same sex marriage in Hawaii.

Rep. Saiki has introduced legislation (House Bill 2802) to propose repealing the 1998 marriage provision in the Hawaii Constitution. The legislation is currently pending. If the Legislature approves it, the constitutional amendment will be placed on the general election ballot in November 2024. Thank you to community advocates who are working on this legislation. # House Moves Aggressive Housing Legislation

The House has taken a bolder approach to build affordable housing. The state has previously provided funds for infrastructure and some construction projects. But this is costly and the federal government no longer subsidizes affordable housing construction at the same rate. This year, the House is advancing legislation that will streamline the zoning process to allow private property owners to build units in residential and commercial areas. The legislation will provide minimum zoning standards but preserve the city's authority to approve and deny building permits. These proposals are found in SB3202.

# Actions Taken to Improve Road Safety

It has been one year since the tragic death of McKinley High student, Sara Yara, at the Kamakee-Kapiolani Blvd. crosswalk. This and other accidents are a major concern of our community. Working with State and City transportation officials, Rep. Saiki and area legislators took these actions within 3 months of the McKinley crosswalk accident:

- Installed speed humps at the crosswalk and Pensacola St.
- Installed a red light camera at the crosswalk
- Began implementation of a left turn signal at the crosswalk

The McKinley crosswalk death was made even more tragic because the driver was cited for more than 200 traffic violations over the years, but never received jail time. Upon learning this, Rep. Saiki met with Prosecutor Steve Alm. As a result, the Prosecutor's Office changed its policy and will now prosecute repeat violators. Rep. Saiki also met with the Judiciary, and the traffic court judges will now be more vigilant in repeat offender cases. Pedestrian and road safety are a top concern of our community. Rep. Saiki will continue to work with transportation officials and area legislators to improve our sidewalks and roads to prevent these kinds of accidents from reoccurring. Thank you to residents who have advocated for increased safety.
