Road repairs set to begin

Potholes, bumps and inadequate drainage will be taken care of after years of neglect

Starting mid-August, the long-awaited resurfacing of Queen Street in Kaka'ako will finally begin! This marks a major milestone for our neighborhood on an effort that has taken over a decade and tremendous work from many people in our community and within many agencies. Now, with the State having successfully transferred ownership of various roads to the City, these much-needed repairs and enhancements can finally move forward.

Elroy Hamada, the owner of Hamada General Store located right on Queen Street, expressed how transformative this project will be for local residents and businesses. The repaving will not only improve road conditions but also enhance the overall safety and accessibility of our streets. I think for the residents who live here, now that we have all the condos, putting in the sidewalks make it safer for them to walk and use the neighborhood they live in."

Now, over ten years after we began working with the State Attorney General and neighborhood businesses to establish legal ownership of Queen Street, the Circuit Court judge ruled that Queen Street is a public road, allowing this critical work to move forward.

Repeated Unlicensed Driver Bill Signed Into Law



Dear Neighbor,

I'd just like to take a moment to reiterate how grateful I am for your efforts in reaching out to Governor Green to urge him to pass sign HB2526 into law, which increases the penalty for repeat unlicensed drivers to a Class C felony.

Your influence made all the difference in passing this bill, which will significantly enhance road safety in not only our community but across the state. A special thank you to the Citizens Patrol group for your dedication and hard work in advocating for this bill.

As reported by the Star Advertiser, "Of the six bills signed into law without alterations, one drew a significant push from supporters and the quickest response by Green, who signed House Bill 2526 Friday after including it on his potential veto list issued June 21. This bill was passed to increase penalties for a third or subsequent offense involving unauthorized use of a motor vehicle to a Class C felony, under which a court could order forfeiture of the vehicle involved."
