We are about halfway through the 2022 legislative session and hundreds of bills and resolutions are still being actively considered. It's "Crossover" time, which means all the remaining House bills cross over to be debated by the Senate. I am excited to report that the Capitol reopened on March 7th, following a two-year closure due to the COVID-19 pandemic. It's great to have the public back with us after such a long time.

Zoom testimony is still being accepted, and all of our hearings and floor sessions are being broadcast on the House and Senate YouTube pages. If you happen to be on Oahu, you are welcome to testify in person and attend floor sessions, but you must have documentation of complete COVID-19 vaccination or a negative test that is less than 72 hours old.

If you have any questions, please do not hesitate to contact my office; our team is happy to guide you as you navigate the legislative process.
