# REPLANTING KULA STATE FOREST RESERVE

Nearly 2,300 acres of the Kula State Forest Reserve were burned in the early 2007 wildfires. In response, the State legislature appropriated over \$3 million to support the Kula Forest Restoration Plan.

Although the fire was very unfortunate, it also holds great promise. The wildfire burned both native and alien plants, and we are now presented with the opportunity to plant more native plants in order to support native species.

The state appropriated \$3,115,000 in special funds over the 2008-2009 fiscal biennium to aid the reforestation plan. This is the largest amount ever allotted for a reforestation project.

State forestry officers chose a mixture of both native and non-native species. Redwood trees will be planted in place of pine trees, as they have both enormous potential commercially and are less susceptible to fire.

The redwood trees will be planted with approximately 57,000 native plants that have been provided by the Native Nursery in Kula.

Tree seedlings can be planted until the end of Spring, and there is also an ongoing effort to assist in hand weeding of priority areas.

Volunteers will play a key role in the reforestation efforts. To date, nearly 120 volunteers representing six organizations and schools have donated 384 hours of time, planted 1,800 seedlings, and hand weeded 3.5 acres.

Volunteers ages range from elementary school age children to adults.

Young children will require adult supervision.

#### Bringing Water to Upcountry Maui Through a Reservoir

As you know, Upcountry Maui has historically been victim to long dry spells and droughts. As our water resources are so fragile, I introduced a bill that appropriates over \$1.9 million of State funds for the planning and design phases of a 300 million gallon water reservoir. Since this reservoir will be such a large project, the State will work in collaboration with the Federal and County governments. Once complete, the reservoir will protect Upcountry residents from drought. We will provide water to our homes and farms even in the driest of times. Midway through the 2008 Legislative Session, House and Senate lawmakers voted on hundreds of bills reflecting the state's most pressing needs and issues. These bills have now crossed into their non-originating chamber, so that the House can review Senate bills and vice versa. At the start of the session, the House Majority Package and the Joint House and Senate Majority Package focused on key areas.

These package ideas continue to move forward, along with other important issues facing out State.

#### Protecting Hawaii's Small Businesses

The Hawaii Small Business Bill of Rights, was introduced to protect Hawaii's small businesses by providing small business owners with certain protections and guarantees when dealing with State governments. Once this important piece of legislation passes, business owners who feel wronged will be able to easily file a complaint that will be investigated by the Ombudsman. Small businesses are a major driving force in Hawaii's economy, and it is absolutely imperative that we protect them.

#### Protecting Hawaii's Uniqueness: Energy and Environment

Hawaii needs a long-term strategy to develop alternative and renewable energy resources. HB2506 directs the Legislative Reference Bureau to do just this, and look at how to best reorganize State agencies that are responsible for the monumental task of developing a long term energy strategy.

The spread of invasive species has had a major impact upon our quality of life; anyone who has had to endure the mating call of a coqui frog can attest to this. HB2501 establishes a Biosecurity Strategy within the Department of Agriculture to prevent and control the importation and spread of pests and other invasive species. This measure provides funding for the establishment of joint federal/ state inspection facilities at our airports and harbors.

#### The State Budget

The House is taking a fiscally conservative approach to the Executive Budget this year, and proposes to cut about \$67 million or 1.27% of the current budget. A proposed budget approved by the House of Representatives expend approximately \$10.7 billion. The House Committee on Finance emphasized the need to prepare for tough economic times ahead as the Federal economy slips into recession. However, sound fiscal management will allow us to maintain government services for the health, safety, and welfare of our people.

#### Protecting our Ohana: Investing in Healthcare

Access to healthcare for residents living in rural areas such as Upcountry Maui, is one of Hawaii's most critical health issues. The Hawaii Health Corps, established by HB2519, will provide loan repayments and stipends for physicians and dentists who agree to work areas with a shortage of health professionals and as first responders during civil defense and other emergencies.

To help the uninsured, the House has passed HB1993, which appropriates funds for nonprofit community based health care providers that will provide healthcare for those who do not have health insurance.

Lastly, HB584 and HB2778 will help those struggling with the cost of long-term care by providing a long-term care insurance tax credit.

# UPCOUNTRY UPDATE

#### Perpetuating the Life of the Land: Agriculture

The state has a constitutional duty to protect agricultural lands and assist the agricultural industry. HB2361 requires the Department of Land and Natural Resources and the Department of Agriculture to identify public lands that should be designated as Important Agricultural Lands (IAL), and transfer the management responsibility of those lands to the Department of Agriculture.

Further, HB 2357 provides various incentives to landowners, including the exclusion of rental income from agricultural leases on IAL's from income and general excise taxes, allowing landowners to develop dwellings for farmers and employees on IAL's, establishing an IAL Qualified Agricultural Cost Tax Credit, and authorizing the Board of Agriculture to guarantee loans for the development to agricultural projects on IAL's.



Investing in our Keikis Future: Education is the Key

Keiki First Steps is the proposed early learning system that provides quality learning programs for children from birth to the time they enter kindergarten. The early education program will be administered by an Early Learning Council, and will focus on expanding existing programs and services for 3- and 4-year-olds, with priority given to underserved and atrisk children.

The legislature also remains committed to tackling the backlog of school repairs and maintenance. HB602 requires that \$90 million be annually deposited into the State Educational Facilities Improvement Special Fund for public school capital improvement projects.
