2017 Interim Session Highlights

<u>The Clift Tsuji Act</u>

HB1325 HD1 SD1 CD1 Act 163 Relating to Biosecurity. "Clift Tsuji Act."

The protection of the State's precious and unique environment is important to all of us who are privileged to call Maui our home. This year I introduced HB1325 to strengthen the State's biosecurity measures. This legislation helps Maui in many specific ways. For example, it increases the inspection capacity within the Department of Agriculture Plant Quarantine Branch to prevent new invasive species from entering our island. It will also increase pest management practices, allowing better control of existing insects and diseases affecting our farms.

To complement HB1325, I secured \$608,000 in the State budget for mobile hot-water treatment units at the docks and production areas. This treatment prevents the spread of Coqui frogs, little fire ants, slugs and snails associated with the Rat Lungworm Disease.

Governor Ige, signed HB1325 into law on Tuesday, July 11, 2017. The full text of HB1325, now Act 163 is available at the <u>http://capitol.hawaii.gov</u> for more information.

Caring For Our Kupuna

HB607 Act 102- Relating to Kupuna Care. Elderly Care.

Improves the care of elderly persons in the State by authorizing the Executive Office on Aging to establish the Kupuna Caregivers Program to assist community members in obtaining care for elders while remaining in the workforce. Appropriates \$600,000 for fiscal year 2017-2018 to establish and implement the Kupuna Caregivers Program. Clarifies procedures for providing and coordinating services and for determining eligibility for services under the existing Kupuna Care Program.

HB615 Act 103– *Relating to the Healthy Aging Partnership Program.*

Supports the health of older adults by appropriating \$500,000 for fiscal year 2017-2018 for the Healthy Aging Partnership Program to further the Program's important role in improving the health and wellbeing of Hawaii's Kupuna.

Helping Families

HB213 Act 128– Relating to Family Leave; Sibling.

Permits an employee to take family leave in order to care for employee's sibling with a serious health condition. Specifies notice and certification requirements.

HB937 HD1 SD1 CD1– Relating to Early Learning. Executive Office on Early learning; Family Child-Child Interaction learning Programs.

Supports the early learning of the young children of Hawaii by appropriating \$300,000 for each year of fiscal biennium 2017-2019. Allows the Executive Office on Early Learning to enter into contracts with third-party providers for family-child interaction learning programs that support families taking an active role in the social, emotional, and cognitive development of their young children. Transmitted to Governor.

For The Community

HB1244 Act 125– *Relating to Cesspools. Upgrade, Conversion or Connection, Tax Credit.*

Requires upgrade, conversion, or sewer connection of all cesspools in the State before 2050 unless excepted. Broadens eligibility criteria for tax credit to offset cost. Requires the Department of Health to investigate existing cesspools, assess incentive programs, and report to the Legislature.

HB427 HD2 SD1 CD1– Relating to Dark Night Skies Protection. Light Pollution; Protection Advisory Committee; University of Hawaii.

Establishes a Dark Night Skies Protection Advisory Committee to assist the University of Hawaii in developing a statewide dark night skies protection strategy to preserve Hawaii's dark night skies. Transmitted to Governor.

Together with District 13 Representative DeCoite and Finance Chair Representative Luke, with the Department of Hawaiian Home Lands to witness the signing of the bill by Governor Ige. HB451, HD1, SD2, CD1, became Act 080 on July 5, 2017.

Successorship

HB 451, HD1, SD2, CD1 Act 080– Relating to Hawaiian Homes Commission Act.

It was a historic day for the descendants of the first Hawaiian Homestead Community of Kalamaula on the Island of Moloka'i. The law reduces the minimum Hawaiian blood quantum requirement of certain successors to lessees of Hawaiian home lands from one quarter to one thirtysecond to reduce the trend of "highest bid" and "leapfrog" homestead lease sales and to encourage lessees to maintain and invest in their residences.

Celebrating Agriculture

SB882 Act 010– *Relating to Farm to School Month in Hawaii.*

Designates the month of October as "Farm to School Month in Hawaii."

Supporting Our Veterans

HB942 Act 035- Relating to Filipino Veterans.

Directs the State Foundation on Culture and the Arts to commission an artist to design and build a monument to honor and commemorate Filipino veterans of World War II and to select the location of the monument. Appropriates \$200,000 from the Works of Art Special Fund.

SB283 Act 11—*Relating to Transportation.*

Honors veterans and their role in Maui history by renaming Mokulele Highway as Maui Veterans Highway.
