Capital Improvement Projects are renovations, repairs, and major maintenance to existing landscape improvefacilities, ments, new construction, land acquisition, and utility modifications. For fiscal year 2018-2019, CIP allocation totaled \$4.68 billion. Maui County will receive \$747 million for FY 2018-2019.

# Crafting the Budget

HB 1900 HD1 SD2 CD1, appropriates FY 2018: \$1,027,951 billion and FY 2019 \$755,454 million in General Obligation Bonds. FY2018: \$2,289,745 billion and \$2,387,779 billion for All Means of Finance.

The state budget bill includes operating and capital improvement monies to run the state government. It has funding for critical health and human service needs. To name a few priorities in the budget are \$4.5 million for three new ambulances, \$15 million to fund homeless services, \$50 million for homeless initiatives and \$570 million for affordable housing programs.
