# **TOWN & UPCOUNTRY UPDATE**

Interim Legislative Session Update

## Highlights

HB1248 HD1 SD2 CD1 (ACT136) was passed to make it easier to vote by establishing voting by mail for all elections statewide beginning with the 2020 primary election and expanding in-person voting and ballot drop-off hours.

SB549 SD1 HD2 (ACT 138) requires restaurants that sell children's meals to replace sugary drinks with water, milk, or 100% fruit juice as a default option.

SB1025 SD1 HD2 (ACT 126) appropriates \$1.5 million to the Kupuna Caregivers program for fiscal year 2019-20 (an increase of \$300,000 from last year) and changes the maximum allocation from \$70 per day to \$210 per week to increase flexibility and options for caregivers.

HB257 HD2 SD1 CD1 (ACT 128) supports the Ohana Zones Pilot Program and provides temporary housing along with social and health services that aim to transition homeless people to affordable housing.
