# Senator Chang's **TOP BILLS IN 2019**

#### **ALOHA HOMES**

**SB 1 and SB 400**: Establishes the ALOHA homes program to develop <u>low-cost homes</u> for sale (99 year leases) to <u>Hawai'i residents on state-owned and county-owned</u> <u>land near rail stations of the Honolulu rail transit system</u>. These homes will be available only to Hawai'i residents who are <u>owner-occupants</u> and own no other real property, but there will be no first time home buyer requirement and no income restrictions. The State will keep <u>75 percent of</u> <u>all profits</u> from all future resales.

### **AUTOMATIC** HOUSING SAVINGS ACCOUNTS

**SB 1310**: <u>Requires</u> employers to offer <u>automatic</u>, <u>opt-out payroll</u> <u>deduction contributions</u> to <u>housing savings accounts</u>, to be administered by a board.

# **CRIME:** ADVERTISING ILLEGAL VACATION RENTALS

**SB 354:** Makes advertising, including online advertising, <u>any</u> transient accommodation or resort timeshare vacation interest, plan, or unit without the proper registration identification number and proper local contact information a misdemeanor. Increases fines for advertisers of entire homes and multiple properties.

#### KAIMUKĪ MIDDLE SCHOOL

November 30, 2018 < Senator Chang took tough questions from very well informed 8<sup>th</sup> graders representing Kaimuki Middle School at the Hawai'i State Capitol.



The Department of Commerce and Consumer Affairs Insurance Division has released its <u>annual sample</u> <u>premium comparison guides</u> for motor vehicle, homeowners, condominium, and renters insurance. The compilations of sample base premiums can be used as a general reference to compare rates and identify other insurance companies. The guides help consumers research and explore options and ensure greater competition in the marketplace.

"Reviewing insurance policies annually could help consumers better understand their coverages and

avoid unexpected expenses. Utilizing these premium comparison guides can help consumers shop and compare to make the right insurance decisions for their situation and needs," said <u>Insurance. Commissioner Colin Hayashida</u>. "While costs are important, consumers should also feel comfortable with their insurer and consider other factors such as financial ratings, stability, insurance product offerings, customer service, and claims processing procedures."

## **GOLD COAST SEAWALL**



For several months now our office has been in contact with several resident associations within our East Honolulu community regarding what I believe to be a critical issue regarding the future of our homes. -

The **Gold Coast Community Association** consists of several residents and representatives for an area of condominiums and cooperative apartments located near the Diamond Head end of Kalakaua Avenue. For several years this dedicated group of concerned citizens have fought to have a Seawall (stretching from 2943 Kalakaua to 3019 Kalakaua) repaired by the State for the safety and well-being of the many, who use it to safely access the beaches below.

Following a State of Hawai'i Supreme Court Decision issued in August of 2017, the Department of Land and Natural Resources (DLNR) has decided against approval of funds to repair the Seawall. Instead DLNR has elected to recognize ownership and responsibility of only "the top of the seawall" rejecting any responsibility for the structures beneath. This position by our State Government has allowed for additional erosion of the Seawall structure exacerbating already dangerous conditions.

Having spoken with leadership at DLNR regarding this issue, I believe their position to be erroneous. While I respect the opinions and viewpoints of the department, the safety of the public and our land structures must be upheld. At the January meeting of the Diamond Head / Saint Louis Neighborhood Board #5, I committed to introducing legislative measures to condemn the Seawall in question, allowing for procurement by the State. It is my hope that through these actions DLNR will recognize the significant risks to our shoreline safety posed by government inaction.

# SENATOR CHANG'S TOP BILLS

#### **CRIME:** LYING TO DPP INSPECTORS

**SB 747:** Adds knowingly making a <u>false statement</u> to a county inspector <u>a crime</u> within the offense of unsworn falsification to authorities.

#### **CRIME**: WEBSITES CHARGING FOR ILLEGAL VACATION RENTAL ADVERTISEMENTS

**SB 716:** Makes it a <u>misdemeanor</u> for a hosting platform to collect a fee for booking services regarding <u>transient</u> <u>vacation rentals that are not lawfully certified</u>, <u>registered</u>, <u>or permitted under applicable county ordinance</u>.

#### **MANDATORY** HAND RECOUNTS OF CLOSE ELECTIONS

**SB 359:** <u>Requires</u> a <u>mandatory manual recount</u> of election ballots in any election for any office when the margin of victory is equal to or less than <u>one-half of one percent</u> of the ballots cast.

#### **AUTOMATIC VOTER REGISTRATION**

**SB 116:** Requires that any person who is eligible to vote and applies for <u>a new or renewed motor vehicle</u>. driver's license, provisional license, or instruction permit, <u>or a new, renewed, or duplicate civil identification card</u> be automatically registered to <u>vote</u> unless the applicant affirmatively declines to be registered to vote.

#### **STYROFOAM BAN**

**SB 11:** <u>Prohibits the sale of polystyrene foam</u> <u>containers</u> and serving of prepared foods using polystyrene foam containers statewide.

#### PRIORITIZE MAINTENANCE OF WATER MAINS UNDER HEAVILY TRAFFICKED ROADWAYS

**SB 360:** Requires <u>public water or sewer utilities</u> to consider the <u>disruption to transportation</u> as a criterion in planning <u>future maintenance</u>.

#### GOLD COAST SEAWALL CONDEMNATION

**SB 5:** Requires the <u>Department of Land and Natural</u> <u>Resources</u> (DLNR) to acquire by eminent domain the seawall and the real property underneath the seawall that is located on or near the seaward boundaries of property between <u>2943 Kalākaua Avenue</u> and <u>3019 Kalākaua</u> <u>Avenue</u>. Appropriates funds for the just compensation of taking, and the <u>repair and maintenance of the entire</u> <u>seawall and the real property under the seawall</u>.

#### FREE REEF-SAFE SUNSCREEN DISPENSERS AT HANA'UMA BAY AND IN WAIKIKI

**SB 353:** Requires DLNR to establish a <u>two-year pilot</u> <u>program</u> to install sunscreen dispensers at Hanauma Bay and Waikiki beaches to provide <u>sunscreens without</u> <u>oxybenzone or octinoxate</u> to visitors and educate visitors



on the <u>harm-</u> ful effects of oxybenzone and octinoxate on the marine environment. Appropriates funds for the pilot program.
