Kapi'olani Boulevard PM Contraflow Reinstated to Improve Travel Time

Beginning on **Monday, April 22**, the city's Department of Transportation Services will reinstate PM Contraflow coning, along with several traffic modifications, on Kapi'olani Boulevard. This will help facilitate eastbound traffic flow along the Kapi'olani Boulevard transportation corridor.

Based on the findings of the Kapi'olani Boulevard contraflow pilot project that began in July of last year, **the original contraflow will be restored** with the following modifications:

- Left turns from the **westbound** direction on Kapi'olani Boulevard into Waikīkī at **McCully Street** will be allowed.
- Left turns from **Kalākaua Avenue**, **mauka**-bound, onto Kapi'olani Boulevard will be allowed.
- Left turns from the **westbound** direction on Kapi'olani Boulevard onto **Atkinson Drive** will again be restricted.
- Eastbound left turns from Kapi'olani Boulevard at Ke'eaumoku, Kaheka, and McCully Streets will be allowed.

Honolulu Police Department Services are Now Available on the Honolulu 311 App

We are excited to announce that the Honolulu 311 mobile application is now being used by Honolulu Police Department to report non-emergency issues, such as: Homeless Concerns, Parking Issues, Abandoned Property, and more. In addition, to make the app more user friendly, we now support submitting Service Requests without requiring a photo or video (although it really helps us when you do!). Also, you can now choose to submit reports anonymously. However, this may decrease our ability to contact you if our staff has follow up questions. Please note, if you're already logged into the app, you'll have to first sign out before you can begin using the app anonymously.

The app is available on iTunes and Google Play.

Department of Health to Develop Guidelines for Food Donation

On April 24, 2019, the Legislature adopted **Senate Concurrent Resolution 38**, introduced by Senator Chang. SCR 38 urges restaurants to donate any leftover food to homeless shelters at the end of their business day and urges the Department of Health to develop and disseminate food donation guidelines.

Many restaurants are unwilling to donate leftover food at the end of the business day to homeless shelters out of fear of being held liable for any health problems that result from their donations. While food donation is protected from liability under the Bill Emerson Good Samaritan Food Donation Act of 1996, restaurants are still reluctant to donate. Often, food is thrown out, which negatively impacts the environment.

The Legislature recognizes the increased need for restaurants to work with various homeless shelters, and **passed** SCR 38 to encourage this partnership to happen.

Real ID Deadline is October 1, 2020

Honolulu's Department of Customer Services is reminding O'ahu residents that if they choose to use their driver licenses or state IDs for air travel, the federal government requires the credential to bear the gold star marking by October 1, 2020. Please note this deadline is approximately 18 months from now.

So far, more than 190,000 O'ahu residents have gotten the Real ID-compliant driver license or state ID since they became available in January 2018. However, nearly 10,000 people are expected to obtain these documents every month in 2020, when their licenses or IDs become due for renewal.

"We want to help residents become aware of this upcoming Real ID date, know how it may affect them, and make decisions early on whether or not they want the gold star marking to meet federal compliance," said Customer Services Director Sheri Kajiwara.

The Real ID Act, which Congress created 14 years ago as a more rigorous security measure following the 2001 terrorist attacks, requires residents to prove their identity through the gold-star marked cards by October 1, 2020 if they want to use that particular credential to board domestic flights and enter federal facilities.

To renew driver licenses or state IDs with the gold star, residents can book an appointment at **honolulu.gov/csd**. The appointment system offers in-person bookings up to three months in advance and online ordering of duplicates. It can take six weeks for a permanent card to arrive in the mail, so residents are asked to remain patient during this waiting period.
