On Thursday, May 23, 2013 the Senate Committee on Tourism and Hawaiian Affairs held an informational briefing to address concerns raised in the Audit of the Department of Hawaiian Home Lands' (DHHL) Homestead Services Division.

Department of Hawaiian Home Lands

The audit of the DHHL's Homestead Services Division, released last month, proved lax oversight, mismanagement, insufficient record-keeping, poor communication and a lack of policies and procedures undermine the agency's mission of serving Native Hawaiians.

Senators and the leadership of DHHL agreed that a better tracking system for loans is sorely needed to ensure delinquencies are better managed. Director Jobie Masagatani pledged to make tangible progress within the next six months.

Aha Moku Site Visit to Kaho`olawe

On May 28th and 29th the Kaho'olawe Island Reserve Commission (KIRC) hosted a handful of legislators and the Aha Moku Advisory Committee (Aha Moku) to brief them on the status of the restoration, operations and management of Kaho'olawe. Another focus of the trip was on the correct cultural protocol to start the Aha Moku in the right way.

The Aha Moku was created by the Legislature and signed into law by Governor Abercrombie through Act 288 on July 9, 2012. The purpose of the Aha Moku is to advise the Chair of the Board of Land and Natural Resources and its department on issues related to land and natural resources management through the aha moku system, a system that is based on the indigenous resource management of moku (regional) boundaries.



A briefing on the status of the restoration, operations and management of Kaho'olawe was given by KIRC.

Post Session Deadlines

Notice of Intent to Veto Deadline: If the Governor has any intent to veto a bill, he must give notice to the Legislature of his plans by the 35th day after adjournment. This year, the 35th day after adjournment falls on *June 24, 2013*. Any bill for which notice is not given will become law, either by the Governor's signature within the next ten days or by effect of law on the 45th day. The Governor's notification of intent to veto does not necessarily mean that a bill will be vetoed. The Governor may decide to sign the bill or simply allow it to become law without his signature.

Veto Deadline: After the Legislature adjourns, the Governor has 45 days (excluding Saturdays, Sundays and holidays) to consider bills presented to him, including those sent to him less than ten days before adjournment. This year, *July 9, 2013* marks the 45th day after adjournment and is the last day for the Governor to veto bills from his intent to veto list. Any bills not signed or vetoed by this date will become law without the Governor's signature.

Special Session: The Legislature may convene at or before noon on the 45th day in special session to amend a returned bill to meet the Governor's objections or to override the Governor's vetoes. The Legislature may override a veto by two-thirds vote of all members to which each house is entitled.
