A Message from Senator Kahele

The 2014 Legislative Session has officially come to a close and I would like to thank the people of Hilo and our State for allowing me the opportunity to serve on your behalf.

When I began this session in January, I set out on one goal, one mission for the residents of Hilo which was to "deliver" the \$33,000,000 needed for the University of Hawai'i at Hilo, Daniel K. Inouye College of Pharmacy building. Today, I am pleased to announce through a collaborative effort of many and the commitment of State Leadership, the funding for the new building was included in the state budget bill. A project like this will have a tremendous impact, as it will bring much needed construction jobs, new students, new faculty and most importantly accreditation to the program. It is an accomplishment we can ALL be proud of!

In addition to this flagship project, we were able to secure an additional \$19 million which will fund other critical programs and projects like the Hilo Medical Center Residency Program, the widening of Puainako Street and the Lyman House Memorial Museum just to name a few.

As a legislative body, we raised the minimum wage to \$10.10 an hour, invested \$3 million to fund early learning through our kindergarten program, preserved and protected the environment with the State's acquisition of 665 acres of conservation land at Turtle Bay and continued to support our kupuna through aging, long term care and investor education programs.

In closing, I wish all of you a great summer! I look forward to seeing you in Hilo and the conversations we will have as we all enjoy this special place we call home.

2014 Achievements

This Session our priorities included increasing the minimum wage, supporting our keiki, and helping our counties. Below are just a few of the bills I'm most proud of passing.

- SB3093 Relating to the University of Hawai`i at Hilo: This measure appropriates \$200K to the University of Hawai`i at Hilo to establish staff positions within the 'Imiloa Astronomy Center. It also supports the University of Hawai`i at Hilo's Memorandum of Understanding with the Revealing Individual Strengths for Excellence (RISE) 21st Century After School Program specifically helping Native Hawaiian children.
- SB2609 Relating to Minimum Wage: Minimum wage will increase from its current \$7.25 an hour to \$10.10 an hour by 2018. To help protect small businesses, we kept the tip credit (allowing employers to deduct 75 cents per hour from tipped employees) but raised the trigger to \$7 above minimum wage.
- HB1671 Relating to Transient Accommodations Tax: For 2014 and 2015, the amount of transient accommodations tax revenues allocated to the counties will increase from \$93,000,000 to \$103,000,000. This means an extra \$1.8 million per year for Hawai`i County!
- HB1716 Making an Appropriation for Invasive Species Prevention, Control, Outreach, Research, and Planning: This measure provides \$5,000,000 to the Department of Land and Natural Resources' Hawai`i Invasive Species Council to support invasive species prevention, control, research, outreach, and planning. Little fire ants better watch out!

We Got Funding! Capital Improvement Projects HB1700 (State Budget) Grant-In-Aid

- **\$33,000,000;** University of Hawai`i at Hilo; Plans, design, construction and equipment for a new instructional facility for the University of Hawai`i at Hilo College of Pharmacy. Project to include ground and site improvements, equipment and appurtenances, and all project related costs.
- **\$2,000,000;** Youth Challenge Academy upgrade and improvements, Keaukaha Military Reservation, Hawai`i.
- **\$500,000;** University of Hawai`i at Hilo, College of Agriculture, Forestry and Natural Reserve Management; Plans, design, construction and equipment to establish the temporary site for the University of Hawai`i at Hilo International Flight Training Center.
- **\$500,000;** Puainako Street widening/realignment, Kanoelehua Avenue to Komohana Street, land acquisition and design for widening and realigning Puainako Street from 2 to 4 lanes from Kanoelehua Street to Komohana Street.
- **\$2,500,000;** University of Hawai`i at Hilo Astronomy; Construction for the modernization and repair of the 2.2 meter telescope on Mauna Kea.
- **\$500,000;** Hilo Harbor Modifications; Plans to modify the turning basin, entrance channel, and other physical features to improve navigational safety and operational efficiencies at Hilo Harbor.
- **\$2,000,000;** Hilo Medical Center Primary Care Residency Program.
- **\$8,502,936;** Foster Care Payment Rate Increases.
- **\$500,000;** Lyman House Memorial Museum; Construction of a new Island Heritage Gallery. This project qualifies as a grant, pursuant to chapter 42F, HRS.
- \$329,000; Hawai`i County Economic Opportunity Council; Plans, design, construction and equipment for a Botanical Garden at Rainbow Falls. This project qualifies as a grant, pursuant to chapter 42F, HRS.
- **\$250,000;** The Food Basket, Inc.; Construction for infrastructure repairs and deferred maintenance. This project qualifies as a grant, pursuant to chapter 42F, HRS.

Hilo International Flight Training Center Takes Big Step

The proposed aviation program at the University of Hawai'i at Hilo (UHH) and Hawai'i Community College (HawCC) took a big step this session as Senator Kahele was able to secure \$500,000 of capital improvement project funding for the startup classrooms and other facilities for the new program.

Ray Bedard, UHH adjunct faculty adviser and aviation program expert has completed the ATP and RFP for the proposed programs and will be presenting to the Board of Regents later this year. Although the aviation appropriations in SB3092 were unable to clear the conference committee deadline, Senator Kahele will continue pursuing the funding for the aviation program next session.



University of Hawai'i at Hilo Daniel K. Inouye College of Pharmacy

The University of Hawai'i at Hilo, Daniel K. Inouye College of Pharmacy is coming together - literally. On Friday, April 25, 2014 it was announced by the Senate Ways and Means and House Finance committees, that the state will invest \$33,000,000 to build a permanent facility for the DKI College of Pharmacy. This has been a long time coming and was accomplished with communities of people coming together and working towards a unified goal!
