Role in the State Legislature

During his first year, Senator Dru Mamo Kanuha was given the role of **Majority Caucus** Leader for the 30th Legislature of the State of Hawai'i. As Majority Caucus Leader, Senator Kanuha presides over the Caucus' regular meetings – meetings that allow legislators of the same party to discuss legislation prior to voting on the Senate floor.

Before any legislation has the chance to be voted on by the entire Senate body, however, it is referred to different committees that bring focus to discussion on topics that are pertinent to the State.

Senator Kanuha is a member of four Senate committees. As Vice Chair of the **Housing** (**HOU**) committee, Senator Kanuha works directly on issues such as affordable and public housing, community development and the sheltering of the homeless. As a member of **Ways and Means** (**WAM**), Senator Kanuha has a very unique role in working out the State's budget and taxation policies. Membership in the **Education** (**EDU**) committee affirms Senator Kanuha's commitment to strengthening our District's public schools and public libraries. Finally, membership in the **Government Operations** (**GVO**) allows District 3 a voice in maximizing government efficiency and overseeing the operation of State departments.

Lifeguards, Physician Assistants and Clean Highways



Lifeguards for Kua Bay Since 2013, there have been 10 spinal cord injuries and 30 significant emergency incidents that have required transport to a hospital from Kekaha Kai State Park. This session, Senator Kanuha secured **\$480,000** in general funds in fiscal year 2020 and fiscal year 2021 for lifeguard services at Kua Bay.

Physician Assistants

In an attempt to address our State's physician shortage, Senator Kanuha introduced SB1406 SD1 HD1 to authorize supervision of physician's assistants (PA) by physician groups, permits supervising physicians and groups to establish practiceappropriate record review policies, establishes continuing education requirements and authorizes audits to enforce compliance, and clarifies provisions relating to forfeiture and reinstatement of a license

Clean Highways

In a response to constituent concerns about dumping at the intersection of Queen Ka'ahumanu Highway and Palani Road, Senator Kanuha introduced **SCR83** and **SR60** to request the Department of Transportation (DOT) to clean up the site. This parcel of land became a dumping ground for rubbish, and was finally cleared by the DOT in mid-April.



24M Secured for Capital Construction

Kealakehe

Elementary School received \$15 million for construction of a new classroom building and various other improvements.

Ka'ū Hospital \$500,000 received for renovation of bathrooms, kitchens and flooring.

Kealakehe High School received \$3 million for an allweather synthetic track.

Ka'ū High and Pahala Elementary School received \$200,000 for various improvements.

West Hawai'i Community Health Center received \$220,000 in GIA funding.

Kealakehe Wastewater Treatment Facility received **\$900,000** funds to match the County of Hawai'i for various projects.

Innovations Public Charter School received \$200,000 for the construction of a community recreational center. **\$1.1 million** was allocated to aquire land necessary to protect important native forest resources.

Konawaena High School received \$1.1 million for improvements to its softball field and \$20,000 for various other improvements. Ke Kula 'O 'Ehunuikaimalino received **\$207,000** for various improvements

Kailua Pier received **\$150,000** for replacement of an old loading dock.

Ho'okena Elementary School received \$200,000 for various improvements.

Honalo Marshalling Yard Facility received \$1.1 million for various improvements as well as Hawai'i 'Ulu Producers Cooperative received \$150,000 for the additional projects at the yard.

Japanese Cultural Center of Kona received \$70,000 in GIA funding.

Notable 2019 Legislation

Kupuna Care

HB465 HD1 SD2 appropriated **\$4.1 million** to the Department of Health to fund the Kupuna Care Program.

Rapid 'Ōhi'a Death HB1548 HD1 SD2 CD1 Appropriated \$750,000 to study and combat rapid 'ōhi'a death.

Homelessness HB157 HD2 SD1 CD1

appropriated **\$2 million** for construction of temporary units for temporary housing of the homeless through the **Ohana Zones Project. SB471 SD2 HD1 CD1** allocated **\$10.8 million** for other homeless programs.

Education HB1070 HD1 SD1

CD1 provided **\$600,000** to the Grow Our Own Teachers Initiative to recruit supplemental education staff to address our State's shortage of teachers.

DaBux Funding

Provided **\$50,000** in matching funds for low-income families to double their purchase of locally-sourced produce.

Doubling Production and Exports

Appropriated **\$100,000** for doubling food production in, and exports out of the State by 2030.

Marijuana Decriminalization HB1383 HD2 SD1 CD1 decriminalizes possession of 3 grams or less of marijuana.

Protecting Rays HB808 HD1 SD2 CD1 outlaws capturing or killing any rays in state waters.

Looking Ahead

What to expect for the 2020 Legislative Session

Alleviating Traffic

While the recent widening of Queen Ka'ahumanu Highway has benefitted West Hawai'i's roads, "crawls" around the district during morning and pauhana commutes are still far too prevalent. A bill was introduced this session to request funding to widen Kuakini Highway between Lako Street and Kamehameha III Road along with a follow-up resolution to request the DOT to prioritize this project, and will be revisited next session.

Ka'ū Hospital

Located over 50 miles away from the nearest medical center, Ka'ū Hospital's four-bed emergency department serves over 3000 patients a year. Through discussion with Ka'ū Hospital's Administrator, Merilyn Harris, it has been identified that an expansion of the hospital's Rural Health Clinic would help improve access to urgent care and outpatient behavioral health services – intended on alleviating pressure on the emergency department.

Advocating for Kona and Ka'ū Coffee Industries

Counterfeit coffee has been a problem that has long plagued our community. Senator Kanuha introduced a variety of legislation this session to mitigate this problem and plans to continue working together with local farmers throughout Kona and Ka'ū to ensure that the coffee being labeled as "Kona" or "Ka'ū" Coffee reflects the quality of coffee that our district is famous for.

Affordable Housing and Workforce Development

As Vice Chair of the Senate Committee on Housing, Senator Kanuha introduced a variety of legislation to address Hawai'i's housing crisis. In addition to legislation to give priority to applicants for housing who work within 25 miles of housing sought, the Rental Assistance Program and Qualified Nonprofit Housing Trust Program were reevaluated. Senator Kanuha also plans to continue advocating for non-conventional housing approaches—such as tiny homes and micro housing units.

Agriculture and Environmental Protection

The passage of SR112 was championed by Senator Kanuha and requests the Department of Land and Natural Resources (DLNR) to prioritize the control of high-threat invasive species.

Senator Kanuha has also tirelessly advocated for all counties in Hawai'i to incorporate the United Nation's Sustainable Development Goals into their respective county codes.

Education

In addition to the funding secured for our district's schools, Senator Kanuha is committed to improving access to education throughout West Hawai'i. In conjunction to a study on the feasibility of a new teaching hospital, Senator Kanuha has advocated to include cardiopulmonary resuscitation (CPR) instruction into the curriculum for public high school in the district. This session, a bill to initiate a tax-free holiday for school supply shopping will be revisited.

Shorelines

As a site of big cultural significance, the issue of jurisdiction at Kahalu'u Beach Park is one that came up a lot this session. SR168 and SCR209 were passed to request the different agencies with jurisdiction over the park – DLNR, Division of Boating and Ocean Resources (DOBOR) and the County of Hawai'i – to identify and pursue the best course of action to collaboratively address issues at Kahalu'u.

Another issue that will continue to be evaluated will be the balance of commercial and recreational usage of Kailua Pier. SR109 was passed to encourage the implementation of quarterly meetings between DOBOR and Division of Conservation and Resources Enforcement (DOCARE) to open dialogue regarding these issues.

Economic Development

Tourism has long been the driving force of Hawai'i's economy-comprising 21% of the state's economy directly, with many of Hawai'i's largest industries revolving around a constant flow of tourists. To diversify our community's revenue generating industries, SCR86 was passed to request Department of Business, Economic Development, and Tourism (DBEDT) to conduct a study on potential areas of economic development other than tourism in the County of Hawai'i. Senator Kanuha has also been an advocate for alternative sources of revenue, such as Mega Millions and Power Ball, and increasing taxes on tobacco products to further replenish the State's
