Aloha friends and neighbors,

It's always nice to begin a report with good news.

Earlier this month, a resident of Waikele contacted elected officials to let us know he was having difficulty hearing the civil defense warning sirens during the monthly tests on the first working day of the month. There is currently no siren in Waikele proper; area residents rely on the siren from nearby Crestview, across Kamehameha Highway. State Civil Defense explains that this is common for inland communities such as Waikele and Crestview that are both outside the tsunami zone. Although residents might not hear a warning siren,

they should have plenty of time to react to warnings that come via other means – cell phone alerts, Emergency Alert System broadcasts over radio and TV, social media alerts, and friends and family calling each other.

Nevertheless, in response to the Waikele resident's concern, I contacted Adjutant General Daryll Wong who heads the department that administers State Civil Defense. I was pleased with the prompt - and positive - response I received. They confirmed that Waikele does not have its own siren, but also noted that the nearby siren in Crestview had "a major malfunction and is not repairable," and thus was not in service on the July 1 test day. As a result of my inquiry, Civil Defense conducted a review of their modernization and replacement schedule, and I am pleased to report the following:

• The malfunctioning Crestview siren has now moved up to the "emergency repair" list and will be replaced no later than January 1, 2015 – fewer than six months from now. The new siren in Crestview will be of the type pictured at right, and it should be audible many places in Waikele.

• Civil Defense says that a new, dedicated siren for Waikele is scheduled to be installed at the Community Park in 2016.

The location of sirens close to or within residential neighborhoods is important for the safety and security for our communities. I will continue to monitor this matter to make sure the installation of the new siren in Waikele remains on track.

• Polls are open on Election Day – Saturday, August 9 – from 7 a.m. to 6 p.m.

Little fire ants a BIG concern . . .



When the State Department of Agriculture confirmed the presence of the Little Fire Ant in Mililani Mauka, my colleague, Senator Donovan Dela Cruz, and I knew immediately that the people of our community needed to know about this tiny pest with the big bite.

We scheduled a town hall meeting for mid-July, and the huge turnout told us that our neighbors are taking this "invasion" very seriously.

The Little Fire Ant may have been present in Mililani for several years according to the Department of Agriculture. A thorough inspection has identified the infested area as 15 to 20 house lots along Auina Street, in an adjacent gulch, and across the gulch along Kopalani Street. The ant is considered one of the world's most invasive species. It has been found on Hawaii Island since 1999, and in December 2013 was detected on *hapu'u* (Hawaiian fern) logs on Maui and Oahu. More recently, six acres in Waimanalo have been treated to control and eradicate the pest. In his presentation, DOA spokesman Rob Curtiss said that the ant can be eradicated through the use of pesticides and community participation. But he warned that everyone in the neighborhood needs to cooperate and allow treatment of their property. **The DOA said it will be meeting with Mililani Town Association and individual homeowners before the end of July.**

You should know... Changes to the cell phone ban passed by the legislature in 2013, prohibiting the use of mobile electronic devices while operating a vehicle, went into effect on July 1. The amendments to the law include exempting drivers who are completely stopped and pulled over in a safe zone with their engines off, making a violation a traffic infraction (eliminating the need to go to court), and changing the penalties for violations. The fines in the new law have changed to a flat fee of \$250 for first and multiple violations and \$300 for violations in a school or construction zone.

Loving our laptops! Mililani Mauka and Mililani Waena are among eight schools statewide that have been participating in the Access to Learning Digital Pilot program. Every teacher and student in these schools has a laptop computer. The first evaluation of the program by Associate Professor Jonathan Schwartz from the Education Division of UH West Oahu concludes that teachers, students and parents are overwhelmingly positive about the benefits of using computers in the classroom. Teachers say they have already witnessed measureable improvements in student work and learning.
