### (D) Senate District 18 – Serving Mililani Town, Waipio Gentry, Waikele, Village Park, Royal Kunia



Aloha friends and neighbors,

The two tropical storms that have passed near Oahu this year are vivid reminders of how important it is to be prepared for emergencies – and also how important our emergency warning systems are. I've reported previously about the malfunctioning civil defense siren in Crestview that also serves as a warning device for the neighboring communities of Waikele and Waipio Gentry. **State Civil Defense informed me this month that a replacement for the Crestview** 

siren should be in place in early December - a few weeks ahead of schedule - restoring service to those three communities. Also, warning coverage will greatly improve with a new siren to be installed in Waikele Community Park - also ahead of schedule—sometime in 2015. We are grateful to State Civil Defense for moving ahead on these two projects.

I am pleased to report that a contract has been awarded to Haron Construction of Pearl City for \$253,600 for construction of a second ramp to provide additional disability access to the **Kaleiopuu Elementary School campus in Village Park** as well as quicker evacuation from the campus in the event of an emergency. The award notice indicates that work on the new ramp should begin soon. Also, I was notified that a contract for \$221,386 has been approved for Henry's Equipment Rental and Sales of Waianae for a variety of repair and maintenance projects at **Kipapa Elementary School in Mililani**. Both of these awards are important for upgrades and improvements at our campuses, and also for providing jobs for our Hawaii workers.

Funds in the Legislative budget are now available to address needs of Central Oahu farmers:
\$300,000 - Kunia Agricultural Park - Supplemental design funds to create a 150-acre agriculture park located on prime agricultural land in Central Oahu. The plans include provisions to subdivide the land parcel into 24 agricultural lots with 24 corresponding residential lots.
\$250,000 - Waiahole Water System Improvements - Planning and design funds for Improvements to install a pipe in deteriorated sections of the Waiahole Ditch that brings water from Windward Oahu to Central Oahu farmers.

Senate meeting in two day Special Session

As this newsletter is being prepared, the State Senate is meeting in special session to consider nominations for judicial positions. Margaret Masunaga has been appointed as a District Court judge for Hawaii Island. Attorney Jeffery P. Crabtree and current District Court Judge Christine E. Kuriyama would fill Circuit Court vacancies on Oahu. The Hawaii State Constitution provides that these appointments must be approved by the Senate.

## Hawaii.gov judged 'Best of the Web' for 2014

Hawaii's online Web portal – **Hawaii.gov** – was judged best in the nation by the Center for Digital Government that recognizes the best of all government Web sites across the US. **Hawaii.gov** is a one-stop Internet site that facilitates access to State government agencies for services to the public, businesses and consumers, even for visitors who are planning travel to the islands. Domestic Violence Awareness Month

October is recognized as *Domestic Violence Awareness Month.* As part of the effort to heighten awareness of the seriousness of this issue, I joined my fellow women legislators and other women's organizations at an event hosted by the Hawaii State Commission on the Status of Women. Commission Chair Catherine Betts is at the podium in the photo above. U.S. Senator Mazie Hirono also participated in the program.

Statistics from the U.S. Centers for Disease Control and Prevention show that 35.7 percent of women in Hawaii and 21.8 percent of men have experienced physical violence committed by an intimate partner. The figures nationwide are 35.6 percent and 28.5 percent respectively according to the CDC.

The event at the State Capitol also marked the 20<sup>th</sup> anniversary of the passage of the federal Violence Against Women Act that has provided resources for agencies working to educate family members about the devastating effects of domestic violence and to improve services to those suffering from abuse.

As pointed out in my previous newsletter, I am a champion for *Coaching Boys into Men* adopted by Mililani High School – the anti-violence program that teaches boys on athletic teams about respecting women and modeling respectful behavior for their peers.

# Constitutional amendments on the ballot

The Legislature approved five amendments to the State Constitution that will be on the November General Election ballot for voters to consider.

- Please review these important issues carefully as you prepare to vote.
- The wording for each question is exactly as it will appear on the ballot.

#### Question 1 – HB 420

"Shall the judicial selection commission, when presenting a list of nominees to the governor or the chief justice to fill a vacancy in the office of the chief justice, supreme court, intermediate appellate court, circuit courts or district courts, be required, at the same time, to disclose that list to the public?"

**From the Legislature's committee report**: On November 15, 2011, the Judicial Selection Commission amended its rules to disclose the list of judicial nominees to the public at the same time the names are transmitted to the Governor or Chief Justice, as applicable, to appoint a justice or judge to fill a vacancy on the state bench. This measure adopts this rule change by amending the Hawaii State Constitution to explicitly require the disclosure of the names of the judicial candidates, thereby increasing the transparency of the judicial selection process.

#### Question 2 – HB 748

"Shall the State be authorized to issue special purpose revenue bonds and use the proceeds from the bonds to assist agricultural enterprises on any type of land, rather than only important agricultural lands?"



<u>From the Legislature's committee report</u>: This measure seeks to aid Hawaii's agricultural community by supporting efforts to achieve food security and sustainability throughout the State. The special purpose revenue bonds authorized by this measure will alleviate the burden on producers and processors by offsetting the costs of transportation and replacement of aged and obsolete infrastructure, as well as address regulatory compliance issues. This measure will provide a lower cost financing mechanism to Hawaii's farmers and ranchers to carry out many critical agricultural projects that will help improve Hawaii's economy while enhancing the State's ability to be agriculturally self-sustaining.

#### *Question 3 – SB 886*

"Shall the mandatory retirement age for all state court justices and judges be increased from seventy to eighty years of age?" <u>From the Legislature's committee report</u>: There are a number of judges and justices who are willing and able to serve on the bench past the current mandatory retirement age of seventy. While your Committee recognizes that a mandatory retirement age ensures continued opportunities to serve on the bench, it believes that judges and justices who are willing and able to serve should be allowed to do so until the age of eighty.



#### **Question 4 – SB 1084**

"Shall the appropriation of public funds be permitted for the support or benefit of private early childhood education programs that shall not discriminate on the basis of race, religion, sex or ancestry, as provided by law?"



**From the Legislature's committee report:** Your Committee finds that high quality early learning programs that are affordable and accessible for all children are critically important for ensuring the success of Hawaii's keiki. In addition, significant, long-term benefits realized through investments in high-quality, early learning systems have been proven through decades of research. Hawaii is one of only eleven states that do not publicly fund early education. Your Committee recognizes the need to form public-private partnerships to provide Hawaii's keiki with high-quality early childhood education. This measure will authorize the implementation of S.B. No. 1095 (2013), to allow the Office on Early Learning to contract with private early learning education programs, which have been the primary providers for early education in Hawaii.

#### *Question* 5 – *SB* 2876

"Shall the State be authorized to issue special purpose revenue bonds and use the proceeds from the bonds to offer loans to qualifying dam and reservoir owners to improve their facilities to protect public safety and provide significant benefits to the general public as important water sources?"

**From the Legislature's committee report:** Your Committees find that the implementation of the Dam and Reservoir Safety Act of 2007 mandates dam and reservoir owners to bring their dams and reservoirs into compliance. Over eighty percent of the dams in Hawaii were constructed before 1940 to support the sugarcane plantations. Due to the age of these facilities and deferred maintenance due to demise of the sugar industry, without needed safety improvements, many dams could pose risks to life and property when they fail. Depending on the extent of the required improvements, some dam and reservoirs owners may not have the resources to fund these improvements.

<u>Good news for Mililani residents from the Department of Agriculture and the Hawaii Ant Lab.</u> Two rounds of pesticide applications have worked well to significantly reduce an infestation of Little Fire Ants at a handful of residential properties in Mililani Mauka. An update on the control program was the topic of a second town hall meeting that my colleague Senator Donovan Dela Cruz and I scheduled last week. A third round of treatments is scheduled, with a total of eight treatments that will continue through May 2015. Officials reinforced the importance of residents continuing to watch for the ants to help prevent their spread to other areas. Mililani Town Association is assisting in these efforts by designating Rec Center 6 as a central point where residents can drop off ant samples to be checked and identified. ### Kamehameha Highway work underway!

Many of you are aware that I have worked long and hard with the State Department of Transportation to make major upgrades and safety improvements to Kamehameha Highway that still serves as a vital vehicle corridor between the two distinct areas of my Senate District - Mililani Town and the communities to the south – Village Park, Royal Kunia, Waikele and Gentry Waipio.

Anyone who drives this route knows very well that re-surfacing and other improvements are now underway. As this work proceeds, funds have been appropriated to begin expanding the Kipapa Gulch Bridge from a two-lane to a four-



lane right-of-way as a final major part of the overall Kamehameha Highway work. A total of \$7.3 million has been allocated so far; the project is in the design phase with an estimated long-range completion date of the year 2020 at a total cost of about \$200 million.

#### <u>Did you know . . . ?</u>

Although commonly known as the Kipapa Gulch Bridge, this sturdy structure was originally named the Franklin Delano Roosevelt Bridge after it was originally built in 1933 to honor FDR, just elected 32nd President of the United States. Roosevelt led the country out of a deep recession, creating thousands and thousands of "work relief" jobs to upgrade the nation's infrastructure, including construction of the Kipapa span.

The bridge was designed by W.R. Bartels, Chief Engineer for the Territorial Highway Department, using advanced design concepts of the day. Bartels designed all major territory of Hawaii bridge projects from 1932 until he retired in 1956. The Kipapa Bridge was constructed by the Hawaiian Contracting Company, owned by prolific Honolulu builder Walter F. Dillingham.

Drivers welcomed the new structure with joy because it saved them the tedious drive on the long and winding surface road through the gulch. It will be even better in a few years when it's expanded from two to four lanes!
