March is normally marked by important bill deadlines, and this year is no different. Our shortened session has heightened the urgency to pass important bills that will have a tremendous impact on the welfare of the community as we work to rebuild our economy in the wake of the pandemic. I have included progress on some of the bills I introduced this session to keep you up to date on these measures.

March also marks the celebration of our annual Education Week festivities, which normally invites honored guests to the State Capitol to recognize the achievements of our students, teachers and staff. We were deeply saddened when the 2020 session ended abruptly due to the pandemic last year as it canceled our Education Week plans. This year we anticipated the Capitol remaining closed to the public throughout the pandemic, so in lieu of our in-person presentations on the Senate floor, the House and Senate is recognizing our 2021 honorees with joint certificates and a small makana that were mailed to respective awardees. The challenges of the past year have demonstrated the incredible dedication, determination and resilience of our education community and we are proud to recognize them and their well-deserved honors!

As we enter the final month of session, we remain dedicated and hopeful for the positive changes we are seeing on the horizon. Thanks to the community's diligence in implementing safety precautions and the impact of the vaccine, Hawai'i's cases have remained at a minimum. Achieving this welcomed goal allowed us to reopen to Tier 3 with a significant ease on the difficult restrictions that have plagued us for months. Now officially a year into the pandemic, we are filled with gratitude for the health and safety of our loved ones and have a renewed sense of connection to community. We have realized the power of our collective efforts as we worked together in the past year and continue to make strides as one extended 'ohana. I am proud to announce another joint effort between myself, **Senator Donovan Dela Cruz**, and Mililani Town Association to bring vaccinations to the general public starting this week at Mililani Recreation Center 5! Vaccinations will be available for 4 Thursdays starting March 25th (3/25, 4/1, 4/8 and 4/15) offering the single shot Johnson & Johnson vaccine and administered by Times Pharmacy. Additional information regarding location, time and sign ups are posted on my **Senate Facebook Page** and the **MTA Recreation Center** so be sure to sign up if you are eligible for the Phase 1C category, which includes people over the age of 65, people over 16 with high risk of COVID-19 complications, and other essential workers.

2021 LEGISLATIVE BILL STATUS UPDATES



The 2021 Legislative Session continues to move forward with another big deadline known as crossover. Crossover happens when bills move from the chamber they originated in to the next chamber for further discussion. Senate bills (SB) that have passed out of all of their referred committees will now crossover to the House where they will be heard by their relevant committees. The same will happen with House Bills (HB) coming over into the Senate for their hearings.

SB804: RELATING TO TEACHER RENTAL HOUSING

I introduced this bill because teachers consistently leave the State due to our high cost of living. Housing, or lack thereof, should not be a reason that our students lose the opportunity to learn from great teachers. Opening school lands for teacher housing will not only allow us to draw and retain exceptional educators for our students, but also builds a sense of community in the area they serve. Schools are becoming hubs for the community, whether as gathering places (when it is safe to do so) as well as providing access to health and wellness services.

SB806: RELATING TO PUBLIC SCHOOL LANDS

I re-introduced this friendly condemnation bill due to the stalled ramp project outside of Mililani High School. Concerned constituents have contacted my office asking about the status of this project and we have explained the primary challenge being that although the land was given to the State, the title was never transferred and the state would not indemnify MTA until the title change was completed. I have been working with the DOE and Mililani Town Association (MTA), to transfer the title from MTA to the State in order to resume construction. MTA has been a willing partner in this transfer through the friendly condemnation process and we look forward to construction resuming quickly so that the project can be completed.

SB811: RELATING TO THE DEPARTMENT OF EDUCATION

Our communities have a right to be notified when COVID-19 are confirmed in schools to mitigate the risk of exposure for our kids and families. The DOE currently publishes COVID-19 positive cases by complex area, but as our own communities can attest, these are huge geographic areas. For Mililani, this could be a school in Waialua. For Waipahu, it could be a school in Pearl City. Without school level reporting, we cannot give our families the information they need to make informed decisions on whether or not it is safe for them to send their children back to school, affirming the importance of transparency relating to DOE confirmed COVID cases.

SB1159 SD2: RELATING TO EMPLOYMENT SECURITY

While outstanding issues remain regarding the way that unemployment insurance claims have been handled, another side has yet to be addressed. Unemployment Insurance is not funded by the State, but rather by contributions from employers. When huge surges are in demand for UI claims, the State can step in to ensure that funds are available to those accessing benefits. In order to meet the sudden surge in demand that happened in the past year, the State took out a loan from the Federal Government of \$700 million. Most claims were due to Government mandated shutdowns, and in an attempt to alleviate some of the burdens on Hawai'i's small businesses, the Senate amended SB1159 to potentially pay down the loan so that our the financial burden would not fall upon our local businesses to pay this bill.

1. <u>SB804: Relating to</u> <u>Teacher Rental Housing</u>

Authorizes the Hawaii Public Housing Authority and Hawaii Housing Finance and Development Corporation to provide rental housing projects for teachers employed by the DOE and public charter schools.

3. <u>SB807: Relating to</u> <u>Education</u>

Requires the department of education to submit an annual report on the school academic and financial plans to the board of education and the legislature.

4. <u>SB808: Relating to the</u> <u>School Facilities Agency</u>

Transfers the total fund balance in the state educational improvement fund to the school facilities special fund by a certain date.

5. SB811: Relating to DOE

Requires the DOE to publish a weekly report on schools that have reported COVID-19 cases.

5. <u>SB830: Relating to</u> <u>Employment</u>

Requires each department to establish a telework and alternative work schedule policy.

5. <u>SB1387: Relating to</u> Microchip Identification

Requires dog and cat owners to microchip their pets, if the pets are not licensed.

DENOUNCING ANTI-ASIAN RACISM

We have witnessed a devastating rise in acts of racism, xenophobia and violence against the Asian and Pacific Islander communities in recent months that require a necessary call to action. These distressing acts of targeted violence are untenable, intolerable, and a painful reminder of the work that must be done to ensure safe, inclusive communities for all to thrive.

The passing of Senate Judiciary Committee resolutions SCR 66 & SR 48 affirms the protections of Asian Americans and Asian individuals in the United States as it condemns and denounces all forms of anti-Asian sentimens and all acts of racism,

xenophobia, intolerance, discrimination, hate crime, and hate speech. But these protections also require accountability in the words and actions we choose. Last week I stood united with Senate President Ron Kouchi and Senate Majority Leader J. Kalani English in addressing these concerns and denouncing Anti-Asian violence and racism.

It is our kuleana to protect one another and to uphold the values that distinguish Hawai'i's rich cultural communities. It is not enough to simply share our expressions of sympathy for the racial biases and senseless tragedies that continue to plague our state and country. This moment requires a deeper reflection of the changes we must make to truly practice aloha in action and to demand justice, accountability, respect and equality for all.

COVID-19 RESOURCES:

1. Vaccine Registration

Currently accepting vaccination registrations for kupuna ages 75 and older. Eligibility is required based upon Hawai'i's tiered program and must review the prevaccination checklist before receiving their vaccine.

2. Hawaii Vaccination Plan

For more information regarding Hawai'i's detailed vaccination plan, please refer to the CDC-approved executive summary noting the operational structure to reach high-risk groups as quickly and efficiently as possible.

3. Statewide PODs

A list of clinics or Points of Distribution (PODS) note locations throughout the state where you can receive your COVID-19 vaccination.

4. <u>COVID-19 Vaccine Safety,</u> <u>Expectations & FAOs</u>

One Oahu offers information regarding Hawai'i's distribution plan, vaccine safety, as well as what to expect when receiving the vaccine and a list of FAOs to address community vaccine concerns. It is important to note that people who have recovered from COVID-19 are still urged to receive the vaccine with new variants being introduced into the country and natural immunity varying between individuals. Mask-wearing and hyper hygiene is still urged after receiving a vaccination.

- Gather indoors with fully vaccinated people without wearing a mask.
- Gather indoors with unvaccinated people from one other household without masks (unless one of those people or someone they live with has an increased risk for severe illness).
- Skip quarantine and testing if exposed or someone who has COVID-19 but are asymptomatic

Fully Vaccinated People Must Still:

- Wear a mask, physically distance, and avoid crowds in public, while gathering with unvaccinated people from more than one other household, and visiting with an unvaccinated person who is has an increased risk for severe illness.
- Get tested if you experience symptoms of COVID-19.



Travel Guidelines for Fully Vaccinated People

- CDC travel guidelines have not changed.
- You should still delay domestic and international travel.
- If you do travel, you must follow CDC requirements
