### Aloha!

In the final push until the end of session, the Senate is not slowing down. Conference committees commenced on April 10 and will continue until April 21. I am already scheduled for a number of bills and will represent the WAM (Ways and Means) and EDH (Education nad Housing) committees in various conferences.

Here is an update of bills that my office is tracking:

- HB2197: Gives boards of directors authority to install or allow the installation of solar energy or wind energy devices on the common elements of condominiumspassed Final Reading
- SB2849: relating to the Hawaii-Employer Union health benefits trust fund- received notice of Senate conferees
- SB1059 SD2 HD3: Establishes an illegal fireworks task force to stop the importation of illegal fireworks and explosives received notice of Senate and House conferees
- SR26: urging the Governor to use and consider gender equality when appointing judges and justices to Hawaii courts- report and resolution adopted
- SR81: requesting a report of the wireless enhanced 911 fund- resolution adopted
- SCR164: requesting a study of morning traffic congestion on the Meheula parkway going onto the H2 freeway from Mililani Mauka- deferred by TIA committee on March 22
- SB2124: Makes an \$86,100,000 appropriation from the Hawaii hurricane relief fund to restore the remaining public school instructional days for the 2009-2010 and 2010-2011 school years; provided that the moneys shall only be released upon completion of negotiations of parties necessary to execute the restoration of instructional days. Allocates a proportionate amount of the appropriation to charter schools. Requires unexpended funds from each school year to lapse to the Hawaii hurricane relief fund—Senate and House conferees appointed

### FIREWORKS UPDATE

### HB1987

Establishes a cause of action to abate the illegal purchasing, selling, possession, setting off, igniting or discharging of fireworks. Allows the court to order the closure of any place used in violation of the fireworks law. Allows for the forfeiture of property used in violation of the fireworks law—**report** adopted on 4/6 and assigned Senate Conferees.

### SB1059

Establishes an illegal fireworks task force to stop the importation of illegal fireworks and explosives. Requires the task force to report a preliminary plan to the legislature no later than January 10, 2011. Allows counties to enact ordinances regulating fireworks that are more stringent than state law regulating fireworks. – 3/15, Senate disagrees with House amendments. Senator Kidani assigned to Conference

### FURLOUGH FRIDAY NEWS

On March 23, 2010, the Governor released her proposal for returning students to school for the remaining 21 furlough days. Later, HSTA, BOE and DOE held a press conference announcing their combined proposal.

#### Governor Lingle's Proposal

- Governor Lingle proposes using \$62 million from the state's Rainy Day and Hurricane Relief Fund
- Reinstates only "essential" workers needed to safely open and operate schools
- Teachers give up 9 planning days
- Teachers keep two non-instructional days
- Governor's plan stipulates the legislature must pass a constitutional amendment to allow voters to determine if the next governor should appoint the school superintendent
- Governor's proposed constitutional amendment has stalled in the Legislature—instead, the legislature has advanced another constitutional amendment, **HB2376**, which would let voters decide whether the Board of Education should be appointed by the governor from a list provided by an advisory committee

### HSTA/BOE/DOE Proposal

- Combined plan proposes using **\$92 million** in state funds
- The \$92 million would have to be approved by legislature and appropriated by the governor
- Reinstates all employees
- Teachers would give up 6 planning days
- Teachers keep all non-instructional days
- Average pay cut taken by 10 month teachers due to the furloughs over the two affected school years will be 4.44%
- On March 31, Hawaii's 13,000 public school teachers to vote to approve the deal (vote is not required)

Governor vowed not to release funds unless the legislature passed out the constitutional amendment bills.

### BUDGET UPDATES

After another brutal session, the Senate and House are looking for more solutions for the continued economic struggle. It is now a matter of looking for places that we can trim. Here's an update on the Budget bills that I've been tracking this session that have survived:

- SB2256 SD1 HD1: Authorizes the Department of Education (DOE) to adopt rules governing traffic and parking conditions on roadways and other areas under its jurisdiction, including rules for the assessment and collection of parking fees. Requires the fees collected to be deposited into the same fund into which fees and charges assessed and collected by DOE for the use of school facilities are deposited; provided that parking fees collected by a school shall be deposited to the credit of that school's non-appropriated local school fund account. Effective July 1, 2020- scheduled for Conference hearing
- SB2469 SD2 HD2: Emergency and Budget Reserve Fund; Appropriation (\$) Appropriates moneys from the emergency and budget reserve fund to maintain levels of programs for education, human services, and health. Effective July 1, 2020. (SB2469 HD2)- scheduled for Conference hearing
- SB2124 SD2 HD1: Restoration of Instructional Days; Hawaii Hurricane Relief Fund; Appropriation (\$) Makes an appropriation from the Hawaii hurricane relief fund to restore instructional days for the 2009-2010 and 2010-2011 school years; provided that the moneys shall only be released upon completion of negotiations of parties necessary to execute the restoration of instructional days. Allocates a proportionate amount of the appropriation to charter schools. Requires unexpended funds from each school year to lapse to the Hawaii hurricane relief fund. (SB2124 HD1)scheduled for Conference hearing
- HB2200: To adjust and request appropriations for Fiscal Biennium 2009-11 funding requirements for operations and capital improvement projects of executive branch agencies and programs. (SD2) (\$)-Bill scheduled for Conference Committee Meeting on Monday, 04-12-10 8:00PM in conference room 309

### **AIRCRAFT UPDATE**

Senator Kidani has been working with the Federal Aviation Administration to consider alternate paths away from the Mililani area to decrease headaches and noise in the district. There are Constituent concerns that airplanes are flying over residential areas during peak daytime hours despite complaints of constant noise in the area.

In response, the Federal Aviation Administration (FAA) informed the Senator that flights in the Mililani vicinity do not require communication with Air Traffic Control. The FAA does not exercise any control or regulatory authority over the "South Practice Area" so ultimately pilots are responsible for the operation of their aircraft, which includes complying to the Visual Flight Rules (VFR) and ensuring terrain clearance. The SPA is not designated by the FAA as a practice area. All pilots operating near Mililani are required to adhere to minimal altitude requirements of 14 CFR Part 91.

This is no new issue to the Honolulu Flight Standards District Office which periodically participates in noise meetings with the community and airspace users. Communication with FAA is ongoing and is a work in progress.

### **GOVERNOR'S SIGN OR VETO DEADLINES**

**Bill to Governor** <u>before</u> last 10 days of Session: The Governor can either sign the bill or allow it to become law without her signature simply by failing to veto it within ten days (excluding Saturdays, Sundays and recess days). If she vetoes it, the bill can still become law, if it is reconsidered by the legislature before its adjournment, and is approved by two-thirds of all members of each chamber.

**Bill to Governor** <u>during</u> **last 10 days of Session**: It becomes law automatically on the 45th day after sine die (excluding Saturdays, Sundays and holidays), if it is neither signed into law or vetoed.

MILILANI'S YOUNG SPELLING BEE

### **MTA INTERESTS**

**SB2222:** Conforms planned community association laws with respect to proxies to comparable provisions regulating condominium associations- **Report adopted. Referred to the committee(s) on FIN** 

HB2197/ SB2423: Gives boards of directors authority to install or allow the installation of solar energy or wind energy devices on the common elements of condominiums- Transmitted to Governor

**SB2402:** Suspends temporarily the exemptions for certain persons and certain amounts of gross income or proceeds from the general excise and use tax and requires the payment of the tax at a 1 percent rate **-The Senator and her associates were successful in removing the extra tax to the homeowners association tax. This bill is now pending Final Reading.** 

### A LITTLE BIT ABOUT CONFERENCE COMMITTEES

In the final stage of session, all of the bills that have survived to this point are assigned in Conference, both House and Senate members are assigned to several bills. During this time, testimonies are not accepted and any new changes and amendments may not be added to the bill.

Conference members meet and discuss each bill and are able to make any changes to the language of the bill if it is stated in any DRAFT VERSIONS. The final version of the Conference bill is voted upon by each chamber before the end of the Legislative Session. Bills that are voted and passed are sent to the Governor who has the ability to sign the bill into law or to let it sit in limbo until the next Legislative Session.
