Community Wildfire Protection Plan



Sen. Kim has had many concerns brought to her attention regarding the overall safety of property, particularly in light of the recent devastating wildfires on Maui. There are dry, arid areas in Senate District 14, such as but not limited to the Alewa, Red Hill, and Moanalua areas.

Residents worry about the effects a wildfire might impose on their home. Sen. Kim has inquired with the Dept. of Land and Natural Resources— Division of Forestry and Wildlife about a state fire emergency plan, to which they've informed us of Community Wildfire Protection Plans. These plans are geographically based and usually community-initiated. There is no record of such a plan in our community, so Sen. Kim is reaching out to the Division's Fire Management Officer, Michael Walker, to learn more about how to meet the upcoming application deadline.



Oahu's All-Hazard Outdoor Warning Siren System Defined

- *"STEADY TONE"* Attention Alert Signal follow emergency information and instructions in the form of a local radio, television station broadcast, or cellular Wireless Emergency Alert.
- *"WHOOPING TONE"* HAZMAT-Warning actual HAZMAT incident requiring emergency notification of residents within the vicinity of Campbell Industrial Park. You may need to shelter in place.
- *"HIGH/LOW TONE"* Tamper Alert unauthorized tampering may be occurring of a siren.
- Monthly Siren Alert 11:45 am first business day of each month.
- Out of Cycle Tests Usually to test new equipment, residents will be notified of out of cycle siren tests.
- **Malfunctioning Siren** If you hear a siren sound and there is no emergency information being broadcasted over TV, radio, HNL.info, or official social media, it's more than likely a malfunctioning unit.

Common Signs of a Stroke

B – **Balance loss**. Is there a sudden loss of balance or dizziness?

E – **Eyesight problems**. Is the person experiencing sudden loss of vision, blurriness or double vision?

F – **Face drooping.** Is a side of the person's face uneven?

A – Arm weakness. Is the person experiencing weakness or numbness in one arm or is unable to raise both arms?

S – **Speech difficulty**. Is the person's speech slurred or hard to understand?
