# **Bills That I Will Be Introducing This Session**

**HB287: Vacant and Abandoned Homes**– Requires counties to expedite demolition permits for vacant and abandoned homes.

**HB1557: Squatter Prevention**– Imposes fines on a homeowner, foreclosing party or prevailing purchaser in foreclosure auctions when a vacant residential property subject to foreclosure remains unoccupied during the foreclosure process.– and requires recovered fines to be spent on infrastructure in affected subdivision or district

**HB1180:** Lava Recovery– State budget; Disaster Relief– Appropriates funds for disaster relief, recovery, mitigation and remediation activities for the county of Hawaii.

**HB747: Disabled Persons; Employment-** Establishes employment first as a state policy with respect to disabled persons. Applies employment first principles to Medicaid home– and community based waiver programs.

**HB641: Puna; Boat Ramp**– Makes an appropriation for a feasibility and cost study relating to the construction of a new boat ramp and pier in Puna

**HB643: Homelessness; Appropriations**– Appropriates funds to the outreach program, rapidrehousing program, housing first program, family assessment centers, and coordinated homelessness initiative.

**HB291: Marijuana; Legalization; Authorization–** Authorizes the counties to adopt ordinances to legalize marijuana cultivation, possession, sale, transfer and use for people over twenty one.

## Homeless Summit III

When people think of homelessness in Hawaii; it's Kakaako, Chinatown and Downtown Oahu. As chair of Human Services and Homelessness, I will ensure that the people of Puna's voices will be heard.
Homelessness is an issue that will take a while to solve, but based on testimonies, stories, and results from Homeless Summit III, I'm confident the situation will improve and that homelessness will decrease as we move on forward to a better future.



The 2018 Point in Time Count Information showed homelessness in Big Island has decreased significantly.

- IN 2017– 2018, homeless count decreased 8.8% from 953 to 869 homeless individuals.
- Housing Choice Voucher Section 8 Program: 45 homeless families secured affordable housing.
- The service agencies and County government made a concentrated effort to implement programs that had 234 individuals gaining permanent housing.



#### **INTERIM SURVEY RESULTS:**

- To help Puna Recovery, should government support a LAVA VIEWING SITE? Yes, Allow people to recover losses by making money off their land: 98, Yes, But only on non-residential sites: 0, No, Not culturally appropriate: 29, No, increased theft: 0, Other: 56.
- Should the government help displaced residents move from Lava Zone 1/ Lava Inundated Homes? Yes, By creating a subdivision and allowing a land swap: 168, Yes, Offering low interest loans: 188, Yes, Allowing permit exemptions/tax incentives to make rebuilding easier: 166, Yes, Other: 65, No: 31.
- Puna Geothermal Venture will take at least 18 months to reopen, should it decide to reopen. PGV, which supplied 30% of Big Island Power, has not considered if it will reopen. Do you support the reopening of PGV? Yes: 158, No: 121.
- Should Housing Micro Units be allowed to remain beyond emergency period? Yes, but on a case by case basis: 226, No, Section 8 or other rental subsidized programs should absorb homeless: 42, Other: 50.
- Pohoiki, which supplied over 25% of Big Island fish, has been closed. Department of Land and Natural Resources and its engineers will study where or if to retain the ramp. Should Puna have a small boat fishing? Yes: 262, No: 13, Other: 49.
