Chairing Judiciary Committee Hearing

Being an avid photographer, I participated in Art at the Capitol on Friday, March 6, 2015. Photos that I've borrowed from the <u>State</u> Foundation on Culture and the <u>Arts Hawaii</u> as well as some of my personal photographs are hanging in my office and were available for public viewing.

One of the many visitors to my office that evening was artist Shigeru Miyamoto and his wife.

After the first crossover, when resolutions were being heard during the Judiciary hearings, I was given the opportunity to chair these hearings. The first resolution that I passed was <u>HCR53</u>; requesting the United States Congress to convene a constitutional convention to propose a constitutional amendment to overturn the United States Supreme Court's decision in <u>Citizens United v. Federal Election Commission</u>. The last was <u>SCR98</u>; requesting the judiciary to study which traffic offenses & crimes can be decriminalized.

Capitol Improvement Projects (CIP)

"The <u>CIP budget</u> addresses the most basic necessities for our schools, infrastructure and state facilities," said House Majority Leader Scott Saiki (McCully, Kaheka, Kakaako, Downtown). "The CIP funds are more than just about buildings and roads, but are critical to the services and support we provide to the people of Hawaii."

I've been working diligently to secure money for Highway 130. My request for \$15 million in the <u>CIP budget</u> has passed the house and hopefully with <u>Senator Ruder-</u> <u>man</u> and <u>Councilman Ilagan's</u> help, this \$15 million will be approved.



Homeowners Insurance

I have been working with the Hawaii State Insurance Commissioner, <u>Gordon Ito</u>, on the homeowners insurance issue affecting Puna residents. Mr. Ito assured me that for those who have paid their premiums, and whose insurance was not renewed under <u>SB589 SD2</u> <u>HD2</u>, there will be insurance policies offered to them without a waiting period by HPIA.
