Medical Cannabis Updates



Below are some of the subcommittee recommendations that have passed during the most recent Act 230 Meeting:

1. The existing schedule under HRS Sec. 329D -2 as amended by HB1488 remain. i.e. The State of Hawaii Dept of Health may open new dispensary application process after October 1, 2018 for additional dispensaries/retail establishments based upon the factors stated in HRS Sec. 329D-2. There are no current obstacles to the dispensary application process

so long as the law on the dispensary application procedure remains unchanged.

2. Recommend another working group in 2018 to determine the need for production or other non-retail dispensary licenses and requirements for such new licenses.

- 3. Allow for intrastate travel
- 4. Allow for ALS & Substance/Opioid use disorder
