# \*\*\*FEMA REGISTRATION DEADLINE FOR KILAUEA DAMAGE IS AUGUST 13, 2018\*\*\*

Hawai'i County residents with losses as a result of the Kilauea eruptions <u>and</u> <u>earthquakes</u> have through Monday, August 13, 2018 to register for disaster assistance with FEMA:

Disaster Recovery Center at the Pahoa Neighborhood Facility: 15-2908 Pahoa Village Road in Pahoa.

Monday through Friday: 8 a.m. to 6 p.m. Saturday: 8 a.m. to 4 p.m. Sundays: Closed

You may also register online at DisasterAssistance.gov or by phone at 800-621-3362 or (TTY) 800-462-7585. Applicants who use 711 or Video Relay service may call 800-621-3362.

The toll-free numbers are open 7 a.m. to 10 p.m. seven days a week.

Disaster assistance may include FEMA grants for temporary housing, home repairs and replacement, as well as low-interest disaster loans from the U.S. Small Business Administration. These loans are available to businesses, private nonprofits, homeowners and renters to cover losses not fully compensated by insurance or other recoveries.

August 13 is also the deadline to file a loan application for physical damages with the SBA. Applicants may apply to the SBA online at https:// disasterloan.sba.gov/ela. Applicants may also call SBA's Customer Service Center at (800) 659-2955 or email disastercustomerservice@sba.gov for more information on SBA disaster assistance. Individuals who are dear or hard of hearing may call (800) 877-8339.

Water: 1 gallon per person per day, for 7 days

Medicine: Ask physician for emergency Rx refills

Equipment: cane, walker, glasses, hearing aid

Food: 7-day supply of non-perishable food

#### 'Go-Bag': Have This Ready in Case of Evacuation

\_\_\_\_ Copies of documents in waterproof container (insurance cards, photo IDs, family photo, Rx copies)

\_\_\_ Extra set of car and house keys

Credit & ATM cards; cash, small denominations

\_\_\_\_ Bottled water & non-perishable food

\_\_\_\_ Flashlight, extra batteries

\_\_\_\_ Charger & extra power pack for cell phone

\_\_\_\_ Battery-operated AM/FM radio & extra batteries

\_\_\_\_ Medications and other essential personal items

\_\_\_\_ First aid kit; moist towelettes

\_\_\_ Clothes; shoes; rain gear; jacket; blanket

\_\_\_\_ Family contact & meeting; small regional map

\_\_\_\_ Child care supplies (diapers, food, formula)

\_\_\_\_ Special items like cane or glasses; multipurpose tool with can opener

## Street Bikers United and Minit Stop come through to help Connect Point Church service the houseless community

On July 25, Minit Stop and Street Bikers United Hawaii presented a \$10,000 check to Pastor Dion Maeda in support of temporary living modules that have been constructed on property owned by Connect Point Church in Hawaiian Paradise Park.

Since the start of the lava movement, Pastor Dion and his church have been offering assistance to those who have been displaced by the lava. The donation by Street Bikers United and Minit Stop will help to support Pastor Dion's transitional village, which, is a stepping stone in getting evacuees settled into more permanent housing situations in the future.

In addition to their generous monetary donation, Street Bikers United and Minit Stop have also gathered supplies to be delivered to displaced Puna residents. The 20 foot container of supplies was delivered to Hilo from Maui on July 18th and will provide much needed support for those who are still dealing with the loss of their homes.

At a time when donor fatigue is setting in but the need remains strong, Street Bikers United and Minit Stop came through to help Puna in a big way. I am very humbled by the many wonderful things that Street Bikers United do for the community. Their support for the community is truly a blessing and look forward to working with them again during future legislative sessions.
