2017 Rat Lungworm Disease Briefing at the Capitol

The rat lungworm disease is a serious problem to our community as it threatens our health & safety as well as certain parts of our agricultural industry. Like my fellow legislators I also encourage education as a means of prevention and urge everyone to thoroughly wash produce before consumption, however, at this meeting I raised the issue with the Department of Health as to why we do not also consider eradicating the slugs that carry the parasite. I truly believe that exploring the possibility of eliminating the slugs (many of which are invasive) is a more effective solution to this problem. I also questioned the Department of Health about what is being done to improve early diagnosis of this disease as many people who exhibit symptoms of infection are not immediately diagnosed, which can delay proper treatment.

HB1501-Relating to Drug Paraphernalia <u>passed</u> the Judiciary committee and has been recommended for passage on third reading. If passed, **HB1501** would reclassify drug paraphernalia possession from felonies to civil violations. Passing this bill would help to avoid further congestion of our crowded prisons and ensure that those patients who are prescribed Medical Marijuana are not at risk of being charged with a felony. With licensed medical dispensaries receiving the go-ahead to begin cultivation, it is especially important that this bill be passed into law. Thank you to everyone who provided testimony for this bill. I encourage everyone to track this bill as it moves to the Senate.



A big 'Mahalo' to everyone who provided testimony in support of **HB 172**. **HB 172** passed the committees on Energy & Environmental Protection, Water & Land, and Judiciary.

If passed, **HB 172** would make it easier for property owners to remove hazardous Albizia trees from neighboring properties under certain conditions.

Please continue to support this bill as it moves through the legislative process.

Big Isle legislators being given updates on Rapid Ohi'a Death and forest management by the DLNR. R.O.D., caused by a fungus, is spread to an ohi'a tree when there is an open wound on the tree. DLNR explained the dangers of transporting ohi'a logs from infected areas to non-infected areas.

Some quick tips to help combat the spread of Rapid Ohi'a Death:

-Sterilize footwear and clothing before and after leaving forested areas.

-Avoid transporting or moving Ohi'a wood if you do not know where it is from. If you are not sure of it's original location, it is best to just leave it where it is.

-Clean/sterilize tools after exposure to Ohi'a with 70% alcohol solution. This solution is capable of killing the Rapid Ohia Death fungus.

-Wash your vehicle (especially after off-roading). Thoroughly remove mud and other foliage picked up during travel to avoid the possibility of transporting the fungus to areas along your commute

02/08/2017 Committee on Transportation hearing

This year, I sought a seat on the Committee on Transportation to ensure that Puna's interests were represented during the legislative session. At this committee hearing, I made it very clear that I would be weary of supporting highway projects in other districts, unless I can be assured that these projects would not be given priority over the highway 130 alternate route.



Highway 130 Update

Lately, many have asked why it is not possible for the Hawaii DOT district office to schedule all improvement projects at the same time as a means of consolidating congestion into one period.

While this would be an ideal situation, combining/scheduling all improvement projects during the same time frame would not be viable in this, or any county.

While I have fought hard to secure funding for improvement projects, the state releases the money as it becomes available. With over 200 million+ dollars in funds secured for Puna improvement projects, the money cannot feasibly be released at once, which means that improvement projects, such as the Shower Drive traffic light installation, cannot commence in congruence with the widening project. This presents a difficult situation as deferring projects for the sake of coinciding with other projects will put the funding at risk of being taken by other projects. To put a project on hold would jeopardize it's prioritization, which, is why it is in our best interest for the HDOT to commence with these projects



as soon as the money is allocated in order to avoid further delay of much needed improvements. This year, it just so happens that the ~~~ was able to get funding released for various projects in Hawaii County. We understand that this has resulted in longer commute times and we empathize with the inconvenience that this has caused you. The HDOT respectfully requests your patience with the hope that you understand that this will ultimately benefit the long term interests of the Puna district.
