Aloha,

The 2015 legislative session ended with Puna getting most of what we needed. The Hawaii Property Insurance Association (HPIA) moratorium is lifted and property insurance should now be available in lava zones 1&2.

The mauka shoulder conversion of Hwy 130 from Kea`au High School to Shower Drive has relieved traffic; and we received commitment for more monies to further improve Hwy 130.

Our children will now be able to return to Keonepoko or Pahoa High School. Although the Puna bookmobile request passed the House, it did not get pass the Senate but the Pahoa library should soon be on its way.

15 years after it has been legalized, medical marijuana may be purchased by patients as early as November 1, 2016; and patients retain the right to grow their own. Tweaks on the law need to continue to be done but at least we are on our way. A "Lawmakers Listen" forum of the House leaders will be scheduled in Puna before the next session so you will be able to comment directly to our leaders.



Legislative Accomplishments!

LAVA Insurance Bill

Introduced bill requiring mandatory renewal of policies. Confirmed with HPIA and Ins. Commissioner that despite language of bill that passed, that HPIA insurance will be available for those who have faithfully paid their property insurance and whose homes are insurable.

Chief Election Officer Bill

Requires a performance evaluation after every general election and public hearing before reappointment.

Highway 130

- * Expedited mauka shoulder conversion to relieve Pahoa bound afterwork/ school traffic.
- * Acquired \$15 million for alternate route &/or repair of feeder roads.
- \$450,000 for land acquisition to expand Highway 130 to 4 lanes.

FEMA: Worked with FEMA to ensure reimbursement of \$6-7 million to those who applied. Payment to begin May.



IMPORTANT: REFUNDABLE FOOD/GE TAX CREDIT

For 2015 tax returns due April 2016, there is an increase in the Refundable Food/GE Tax Credit. To get your refund you <u>must</u> file your 2015 Hawaii State tax returns. Because this is a refundable tax credit, you do not need to owe taxes to get a refund but you must file.

SB589 SD2 HD2 - Hawaii Property Insurance Association (HPIA); Policies; Zone; State of Lava Emergency; Moratorium

Removes HPIA's moratorium on property insurance for properties in lava zones 1 & 2. Requires the HPIA to offer new policies.

SB791 SD1 HD2 CD1 -Autism: Mandatory Health Coverage Requires insurance coverage for diagnosis and treatment of autism.

HB321 HD1 SD2 CD1 - Medical Marijuana Dispensaries; For the first time since medical marijuana was legalized 15 years ago, a licensing system for medical marijuana dispensaries is created. A certifying physician need not be the gualifying patient's primary care physician but it still requires a bona fide physician-patient relationship with the qualifying patient. This bill still allows a patient to grow their own medical marijuana. However, this bill allows persons authorized to use and possess medical marijuana in other states to be treated similarly to qualifying patients in this State pursuant to rules adopted by the department of health after 1/1/2018. This bill further authorizes the department of health to conduct criminal history checks on license applicants, licensees, prospective employees of dispensaries and production centers, subcontrac-

tors, and persons authorized to enter and remain on such premises.

JEGISLATIVE REPORT

Bills Passed This Session

SB717 SD2 HD1 CD1 -<u>Ethanol; Motor Vehicles;</u> <u>Energy Efficiency</u> Repeals the requirement that gasoline sold in the State include 10% ethanol. It has been discovered that this requirement of blending ethanol into Hawaii's gasoline does not produce any economic benefit for the State; rather, an economic burden is placed on the state's residents for the importing of ethanol.

HB1343 HD1 SD1 CD1 -Business Recovery Center; Creates a business recovery center within Dept of Defense.

SB1211 SD1 HD1 CD1 - Major Disaster Fund; Expenditure Ceiling Due to the wide range of natural and manmade hazards, which may result in emergencies or disasters that: threaten the life, health, and safety of its people; damage and destroy property; disrupt everyday services, business, and recreational activities; and impede economic development. This act increases the expenditure ceiling on Major Disaster Fund moneys. Appropriates funds for deposit into the Major Disaster Fund.
