Senator DeCoite's Bills & Resolutions Passed through Legislature and Moving onto Governor

## SB739 HD1

## **RELATING TO DESECRATION**

Expanding the requisite state of mind for the criminal offense of desecration to include "knowingly". Simplifies the definition of "desecrate".

## SB799 SD1 HD2 CD1 RELATING TO TIME SHARING PLANS

For time share plans that use title holding trusts, requires the developer to submit a title report evidencing that the title is vested in the trustee. For time share plans that use a notice of time share plan, requires the recordation of the notice and its submission. For time share plans that use alternative arrangements, requires the recordation of any alternative arrangement documents.

### SCR81 SD1 / SR73 SD1

Supporting the Hawaii State Energy Office in the establishment of an integrated Hawaii Pacific Hydrogen Hub.

### SB798 SD1 HD1 CD1 RELATING TO TIME SHARING

Requires a developer's application for registration or annexation to include a list of projects containing out-of-state time share units and a statement that the developer has verified that those units are in compliance or not prohibited under the laws of the jurisdiction where the units are located. Clarifying that a developer is not required to submit any other evidence of such compliance to register in Hawaii.

### SCR170 / SR128

Urging the Department of Transportation to establish a working group to evaluate options that provide additional air service to remote and underserved communities across the state.

## **Budget Highlights**

Axis Deer Mitigation Statewide \$6,165,000 for FY 24 and FY 25 (allocated to Department of Land and Natural Resources)

EMS Molokai Ambulance and personnel \$1,600,000 for FY 24 and FY 25 (allocated to Department of Health)

Bovine TB Mitigation efforts on Molokai. 2 Positions and funding of \$255,792 (FY 24) and \$228,004 (FY25) = \$483,796

Food Innovation Centers – Statewide \$10,000,000 (Allocated to Agribusiness Development Corporation)

- Moloka'i = \$500,000 for community engagement + \$1,000,000 for plans and design

- Maui = \$500,000 for community engagement + \$1,000,000 for plans and design

#### HEALTH, NATURAL RESOURCE PROTECTIONS, AGRICULTURE, TRANSPORATION, AND INFRASTRUCTURE

Maui Health Systems – plans, design, construction and equipment for improvements, repairs, renovations, expansion, modernization and upgrades to Maui Memorial Medical Center, Kula Hospital and Lanai Community Hospital **\$39,700,000** combined for FY 24 and FY 25 General Fund and GO Bonds

Kona Storm Kula Forest Trail Repair – construction for washouts at gulch crossings **\$400,000** (FY 24)

UpCountry Maui Agricultural Park - construction for Kula Agricultural Park Expansion \$20,000,000 (FY 24)

Kahului Airport - construction for improvements to terminals, systems, and facilities at the airport. \$37,771,000 (FY 24)

Kahului Airport Soil remediation - construction for soil remediation; ground and site improvements. \$2,501,000 (FY 24)

Molokai Irrigation System Improvements \$2,000,000 (FY 24)

Ho'olehua Veteran's Cemetery – upgrades and site improvements **\$650,000** (FY 24 and FY25 combined)

Kalaupapa Settlement, remediation of Hazardous Materials \$540,000 (FY 24 and FY25 combined)

#### SCHOOLS

Hana High & Elementary School – Plans, design, and construction for a multipurpose athletic field; equipment and appurtenances \$1,300,000

Kula Elementary School – Design for a multipurpose building with kitchen and infrastructure improvements at Keokea, ground and site improvements. **\$7,000,000** 

Lana'i High and Elementary School- construction for repairs to roofing of various building and gymnasium floors (**\$2,500,000** FY 24) AND designed construction and equipment for upgrades and improvements including but not limited to; gym and floor, roof repairs, teacher housing, basketball and tennis courts and playfields, exterior painting, building compressor, ground and site improvements and other related upgrades and improvements (**\$5,000,000** FY 25)

Moloka'i Complex Area Schools – design and improvements and maintenance projects at Kaunakakai Elementary School, Kilohana Elementary School, Kualapu'u Elementary Public Conversion Charter School, Maunaloa School, Moloka'i High School and Moloka'i Middle School (**\$6, 510,000** FY 24 and FY 25 combined)

Moloka'i Middle School – plans and design for athletics and physical education facilities (\$2,000,000 FY 24)

TOTAL = **\$17,800,000**
