Many of us do and don't even realize it. Some have a few cents to a few hundred or even a few thousand Dollars \$\$\$. It is very easy to check and you can do it yourself from home.

Please use the information on this card to check to see if you, your family members or even your business/organization (past or present) have any Unclaimed property. The list is updated every year. If you do have unclaimed property is it very easy to fill out the forms and get them turned to the Unclaimed Property office. <u>No fees and no lawyers needed</u>.

## **About Unclaimed Property:**

The State of Hawaii Unclaimed Property Law requires "holders" such as corporations, financial institutions, insurance companies, and business associations to **<u>annually</u>** report and deliver abandoned property to the Unclaimed Property Program.

The State of Hawaii holds unclaimed property as a custodian for the rightful owner. The State Unclaimed Property Program publishes a statewide notice annually, listing owner names and last known addresses of abandoned property escheated to the State. The public is encouraged to search for unclaimed property on the State's internet name search database.

**EXAMPLES OF UNCLAIMED PROPERTY ARE:** 

- Contents of safe deposit boxes
- Deposits held by utility companies
- Dormant savings and checking accounts
- Insurance and medical refunds
- Shares of stock
- Uncashed travelers checks, money orders, dividend checks, payroll checks

# How to search for Unclaimed Property:

- Go to the "Unclaimed Property Search Page" https://www.ehawaii.gov/lilo/app
- The site asks for an individual or Business
  Name. Type in your name or business name.
  Click the "I am not a robot" button and hit
  "Search".
- If you have unclaimed property. The property or list of properties will appear with a link to instructions as to how to file the claim.
