


VICTORY FOR OUR REEFS!

We are thrilled to announce that HB 506, supported by Fish Pono, has been signed into law by Governor Green! This important legislation allocates nearly \$5 million to the Department of Land and Natural Resources DOCARE division on Oʻahu. The funding will provide tools like night vision goggles and drones to enforce herbivore fishing regulations. This funding will also combat nighttime poaching and protect critical fish populations that keep our reef healthy.

This law is the result of years of advocacy by Fish Pono and their supporters. It marks a major step toward restoring Oʻahu's overfished reefs. Fish Pono will continue to work with the community and state agencies to promote reef recovery and conservation.

Fish Pono is a community-led organization dedicated to restoring coral reef herbivores (such as the Uhu) and promoting sustainable fishing practices across Hawai'i. Through advocacy, education, and collaboration with state agencies, Fish Pono works to rebuild a healthy reef ecosystem for generations to come. For more information, visit **fishpono.org**.

Hawaiian Electric Updates Wildfire Safety Strategy

Hawaiian Electric has presented its updated Wildfire Safety Strategy (WSS), outlining both current safety measures and long-term plans to protect communities from wildfire risks.

Since the devastating August 2023 Maui wildfires, Hawaiian Electric has implemented a series of interim safety actions, many already underway in 2024, to reduce fire risk in high hazard areas. These measures are part of a broader 2025–2027 Wildfire Safety Strategy, which includes community engagement, risk modeling, and compliance efforts.

Some key updates include:

- Power lines will shut off immediately during faults to reduce spark risk.
- Visual inspections before re-energizing lines—may increase outage durations.
- Spotters will be stationed during high-risk weather events like Red Flag Warnings.
- Drones and cameras deployed to enhance real-time monitoring.
- Vegetation management and pole/fire resistance upgrades are still ongoing.

As a last resort during extreme fire weather, Hawaiian Electric may implement Public Safety Power Shutoffs (temporary outages designed to prevent wildfires). These shutoffs would require close coordination with emergency services and affected communities. To strengthen the grid and reduce risk, the company has proposed a \$190 million resilience plan to protect against wildfires, hurricanes, and flooding. The plan is currently awaiting approval and would be funded equally by federal sources and customers.



HAWAI'I PUBLIC HOUSING APPLICATIONS OPEN!

The Hawai'i Public Housing Authority (HPHA) has announced the notice of multiple Federal Public Housing waiting lists on Oʻahu for low-income residents. The waiting list will be open from 8:00 AM on Monday, June 30, 2025, to 4:00 PM on Monday, July 7, 2025. Start your application at hpha.myhousing.com.

Eligibility for each waiting list varies:

- Central O'ahu Elderly and Honolulu Elderly waiting lists: Applicants must be at least 62 years old and/or a person with a disability.
- Honolulu Family waiting list: Open to applicants seeking one or two-bedroom units.
- Leeward O'ahu Family waiting list: Open to applicants seeking one to three-bedroom units.

The HPHA accepts only online pre-applications for its federal public housing program. After submitting a pre-application, you will receive a confirmation number and receipt. The HPHA oversees programs that provide affordable, safe, and sanitary housing for families across the state. Over 45,000 individuals have been housed through the HPHA's efforts, with around 6,400 families currently receiving monthly rental assistance.

Real Property Taxes Due



Real property taxes are due! The property tax bills will be sent out on **July 20** and are due **August 20**. The treasury accepts three methods of payment: electronic and telephone payment, mail-in checks, and in-person payment.

For electronic check, credit card, or PIN-less debit card, visit honolulu.gov/bfs/property-tax-payments to pay online. To pay via telephone, call 808-825-6819. A convenience fee will be charged by the service provider.

For mail-in checks, money orders, or official (certified) bank checks, make the check payable to "City and County of Honolulu." Please mail the check to:

City Hall (Honolulu Hale) Division of Treasury 530 South King Street, Room 115 Honolulu, HI 96813 This site is open Monday through Friday (except holidays) from 7:50 a.m. to 4:15 p.m. There is also a Curbside Drop Box located outside Honolulu Hale (black/gray box), which is available 24 hours a day. Failure to pay the taxes by the due date will result in a penalty of up to 10%. For each month or fraction thereof, interest will be applied at a rate of 1% and will be applied to all delinquent taxes.

There are also resources for homeowners which can help lower tax costs. Two tax credits are available for homeowners: the Real Property Tax Credit and the Automatic Sprinkler Tax Credit. To apply, ensure you meet all the requirements beforehand.
