



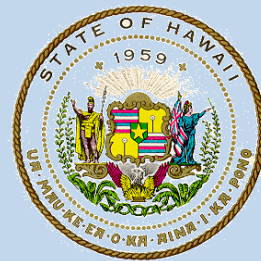

Aloha from Senator Kidani

Aloha,

The Senate received the State Budget from the House on Wednesday, March 16th. In my role as the Vice-Chair of Ways and Means Committee, I have been meeting with various State Departments and various organizations regarding CIP (capital improvement projects). I have also completed CIP visits on Oahu, including Mililani as well as Maui. I am hoping to find the time to visit the Big Island and Kauai to review other CIP requests. These meetings are necessary to learn about CIP needs throughout our state.

The Hawaii State Senate began its current session in January with more than 1,500 pieces of legislation to consider. We passed out more than 325 bills on March 8, 2011 in preparation for First Crossover, the initial major deadline of the legislative session. These bills went over to the State House of Representatives for their review and determination.

They covered a wide variety of areas, such as the economy, human services, medical care, education and the infrastructure on all islands.

The Senate will also receive bills crossed over from the House of Representatives for consideration. All legislation must be finalized and forwarded to the Governor for his consideration by the last day of our 2011 session, Thursday, May 5, 2011.

We have much more to deliberate as we try to balance our very fragile state budget to take care of critical needs while being cognizant of its impact

on residents and businesses if there are tax increases.

This month I was also proud to honor our very own Mililani High School Teacher and Waipio Gentry resident, Mr. John Topolinski during Hawaiian Caucus day on Monday, March 14, 2011.

Balancing the Budget



With the projection on March 10, 2011 by the Council on Revenues, Hawaii faces a budget deficit of nearly \$1 billion over the next two years. The Legislature's priority and greatest challenge will be to preserve essential services for the public while balancing the state budget. The two options are to make cuts to personnel and existing state programs, and/or to increase the state revenue through fees, taxes, and adjust-

ments to credits and exemptions.

Many have urged the state to cut deeper into the budget before raising fees and taxes. The legislature made significant cuts over the past two years. In 2009, the legislature closed a \$2.1 billion deficit, half of which was through budget cuts. In 2010, the state faced an additional \$1.2 billion deficit and again about half of the deficit was closed by cutting programs.

Given that the annual state

general fund budget is normally about \$5 billion, cumulative cuts (\$2.1 billion + \$1.2 billion) were significant to the state budget and its citizens.

The impacts were furloughs, loss of agriculture inspectors which jeopardized food safety, and elimination of many critical programs such as vector control, dam inspections, etc.

As we continue to deliberate the budget, we must be mindful of economic, health and safety impacts to our citizens.



Topolinski Honored as Hawaiian Community Leader

The Hawai'i State Senate on March 14, 2011 celebrated the 5th annual Hawaiian Caucus Day. The day-long event was to honor, preserve and perpetuate the Hawaiian culture through various activities with the theme of "Holomua Me Ka Lōkahi" (Moving forward in unity).

The highlight of the day was the recognition of outstanding Native Hawaiian leaders across the state.

John Renken Kaha'i Topolinski was named by Senator Michelle Kidani who is one of seven part Hawaiian members in the Hawaii State Senate. Caucus members

selected individuals from within their respective districts to join them as honorees in the Senate chamber. Senator Kidani was pleased to select "Kaha'i," a long time resident of Waipahu, for his mana'o, leadership and many contributions to Na Mea Hawai'i (all things Hawaiian).

Kaha'i is a renown Kumu Hula, composer, historian and master feather worker. He graduated in a traditional uniki from noted Kumu Hula Maiki Aiu Lake in 1973 and founded his own hula halau, Ka Pa Hula Hawai'i, whose students are held to the highest standards of traditional Hawaiian dance and chant. He has shared

his knowledge and life experiences with two generations of students of hula, as well as the hundreds of students at Mililani High School where he teaches Hawaiian history and culture.

He is a graduate of BYU Provo Utah; obtained his Masters at UH Manoa and is currently working on his PhD at UH Manoa.

At the request of the British Commission, he honored Princess Diana at St. Andrews cathedral with a Lei Loke Akea chant (White Rose).

Kumu, mahalo nui for perpetuating Hawaiian culture and traditions for future generations.

Kidani Bill Updates

SB641: Fireworks; Requires labeling of display fireworks; requires notification to the county by shipping companies and freight forwarders of incoming fireworks; requires licensee to provide certain info to the county fire department- **This language was incorporated into SB172SD1HD1; passed and being heard in House Committee Judiciary on 3/24 (JUD)**

SB934 SD2 HD1: Cyberbullying; Establishes a bullying and cyberbullying policy for all public schools. Establishes reporting requirements - **passed and referred to House Finance Committee (FIN)**

SB1375 SD1 HD1: Instructional Days; Multi Track Public Schools requires multi track public schools to meet at least 171 days or 90% of the minimum number of days required of other public schools- **passed, referred to House Finance Committee (FIN)**

SB1503 SD2: Department of Education; Education of Students with Disabilities; Accreditation. Requires certain private special education schools and programs that provide services to students with disabilities who receive state funding to comply with federal and state laws, rules and regulations. - **passes as is and referred to House Finance Committee (FIN)**

SCR153: Requesting the installation of automatic sprinklers or application of certified fire-retardant coatings in newly constructed one and two-family residential dwellings to be required under the state building code. - **Referred to Senate Public safety/Water, Land and Housing (PGM/WLH)**

SCR157: Requesting a pilot project to study and reduce the morning traffic congestion on the Meheula Parkway going onto the H2 freeway from Mililani Mauka. - **Referred to Transportation and International Affairs and Public Safety Committee (TIA/PGM)**

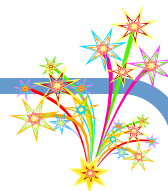

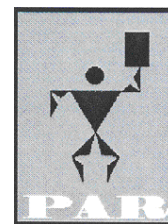
