

# Annual Report on Federal Grants Revolving Fund

October 2024

Section 302A-1405, Hawai'i Revised Statutes, requires the Hawai'i State Department of Education (Department) to annually report on activities related to the Federal Grants Revolving Fund (Revolving Fund). Uses of the Revolving Fund include searching for discretionary grants, developing program applications to secure additional revenues, monitoring grant execution, ensuring compliance with grant requirements, and auditing grant expenditures.

#### LEGISLATIVE REPORT Section 302A-1405, Hawai'i Revised Statutes Federal Grants Revolving Fund

The Federal Grants Revolving Fund (Revolving Fund) revenues are derived from the indirect costs for discretionary and non-discretionary grants. In fiscal year 2024 (FY24), the revenues were \$1,131,387 with an ending cash balance of \$1,637,736.

The following table shows the breakdown of expenditures for FY24.

"A" and "A1" funds were used to support nine (9) permanent full-time employees (FTE) in the Monitoring and Compliance Branch (MAC). MAC evaluates the Hawai'i State Department of Education (Department) compliance with federal laws, U.S. Department of Education requirements, and Board of Education administrative rules and policies related to the implementation of ongoing federally funded programs and provides technical assistance on grant compliance to Department staff.

"B" funds were used to support expenses in the Policy, Innovation, Planning, and Evaluation Branch (PIPE), which is the Department's single point of contact for federal and nonfederal grant application and report submissions and manager of the Capacity Building Grant Program.

PIPE expenses include funding support for grant development activities at schools, complex areas, and state offices under the Capacity Building Grant Program and an eGrants system for tracking and monitoring grants.

The Department will continue to fund the nine (9) positions in MAC through the Revolving Fund in fiscal year 2025.

Activities related to the Revolving Fund during FY24 include the following:

#### 2. Capacity Building Grant Program

The purpose of the Capacity Building Grant Program is to support grant-writing efforts by Department teachers and administrators and to increase funding opportunities at the local level. In FY24, four capacity building grant awards were allocated.

The Kailua-Kalāheo Complex Area received an allocation of \$40,000. These funds enabled the complex area to contract with individuals to provide grant writing training and support to pursue targeted opportunities to meet identified complex area-level needs. Contractors also assisted the complex area in refining logic models and theories of action, identifying intended outcomes, and developing evaluation metrics.

The Pearl City-Waipahu Complex Area received an award of \$5,000. These funds enabled the complex area to contract with a grant writer to pursue a federal grant through the Department of Justice Community Oriented Policing Services Office. PIPE provided ongoing technical assistance.

The School Transformation Branch, within the Office of Strategy, Innovation and Performance, received \$14,500 to contract with a grant writer to support an application to the U.S. Department of Education Full-Service Community Schools Program.

The Kaimuki-McKinley-Roosevelt Complex Area received \$3,000 to contract a grant writer to pursue a Department of Justice School Violence Prevention Program grant on behalf of Princess Ruth Ke'elikōlani Middle School.

#### 3. Other Activities

PIPE also served as the Department's single point of contact for federal and nonfederal grant submissions.

 PIPE acted as the Department's Authorized Organizational Representative on behalf of the Superintendent for the purpose of submitting federal grants online. As the Department's Authorized Organizational Representative, PIPE reviewed grant applications for inclusion of allowable indirect costs and to ensure timely and appropriate Department approvals.
