RELATING TO SEAWATER AIR CONDITIONING DISTRICT
COOLING SYSTEMS.

Allows the sale of cooling from seawater air conditioning district
cooling systems to qualify for state enterprise zone benefits.

Recognizes the contributions of Native Hawaiians in the development

made to local commercial fishing operators under the boat loan
programs or any other state loan program to assist fishing operators to
borrow to build or repair boats for fishing.


