schools facilities fund partnership.

Provides seed money to establish the charter schools facilities fund partnership. Provides a tax credit to landlords who rent or lease to charter schools. Encourages the State to enter into leases charter schools at rates comparable to other State agencies. Reimburses new century charter schools for rent, lease, or mortgage payments for

charter school facilities.

RELATING TO ASSET MANAGEMENT.

Establishes the authority of the Board of Education and Department of

Education to own and administer all lands under Hawaii's public

schools.
