HB 2282 HD1 (HSCR815-06) RELATING TO CHAPTER 846E.

Amends the definition of "repeat covered offender," to expressly except conviction of multiple counts within a single charging document. Adds conviction for a covered offense, unless incarcerated, and released on probation as events requiring a covered offender to register with the attorney general. Clarifies that the prosecuting agency that prosecuted the covered offender for the most recent covered offense within the State must represent the State in any civil proceeding to terminate public access. Allows income withholding to continue when current child support ends where there are outstanding arrears for cases in which Child Support Enforcement Agency (CSEA) services are being provided. RELATING TO SEXUAL ASSAULT.

Amends the law defining continuous sexual assault of a minor to permit the jury to convict if it is unanimous in finding that defendant committed at least three prohibited acts, even if it can not unanimously

agree which 3 acts constitute the offense. (HB2207 HD1)
