
HB 439 HD1, SD1 (SSCR3029)	RELATING TO THE OFFICE OF THE OMBUDSMAN. Authorizes the ombudsman or an authorized representative to obtain state tax returns and return information in connection with the official duties of the office of the ombudsman. Effective 7/1/2006. (SD1)	TGO/JHW, WAM
HB 2214 HD1, SD1 (SSCR3136)	RELATING TO RENTAL MOTOR VEHICLE SURCHARGE TAX. Repeals increase in the rental motor vehicle surcharge tax levied between September 1, 1999 and August 31, 2007. Effective 7/1/06. (SD1)	TGO/CPH, WAM
HB 2215 (SSCR2941)	RELATING TO CONCESSIONS ON PUBLIC PROPERTY. Allows legal tender or financial instruments other than bonds to be used to secure performance under state concession contracts with smaller concessionaires.	TGO, WAM
HB 3123 HD1 (SSCR2971)	MAKING AN APPROPRIATION FOR HURRICANE PREPAREDNESS. Funds a study to assess the structural integrity of each hospital and nursing home facility to determine their ability to withstand hurricanes. Makes appropriation. (HB3123 HD1)	TGO/HTH, WAM
