HB 1834	RELATING TO TELEPHONE SOLICITATIONS. Prohibits phone solicitors from placing calls to residents who are registered on a no-call list. Establishes a website and database containing the no-call list.	CPC/JUD, FIN


DECISION MAKING TO FOLLOW


