SB 1410	RELATING TO INSURANCE. Conforms current statutes to recommendations of the National Association of Insurance Commissioners (NAIC) with respect to: (1) the authority required to implement rules to carry out the directives of the federal Military Personnel Financial Services Protection Act; (2) long-term care insurance; and (3) the sharing of information with the insurance regulatory agencies of foreign countries.
