HB 1415	RELATING TO HIGH TECHNOLOGY BUSINESS TAX CREDITS. Allows analysis and evaluation of relevant information to determine the economic impact of tax credits granted.	EDB, FIN
HB 1631	RELATING TO HIGH TECHNOLOGY BUSINESS INVESTMENT TAX CREDIT. Requires taxpayers claiming the High Technology Business Investment Tax Credit to file certain information with the Auditor.	EDB, FIN
HB 1752	RELATING TO TAXATION. Requires DBEDT to obtain and analyze certain information pertaining to tax incentives. Appropriates funds.	EDB, FIN
HB 1897	RELATING TO THE HIGH TECHNOLOGY BUSINESS INVESTMENT TAX CREDIT. Reduces the tax credit to 50 percent over five years. Adds additional requirements to the taxpayer's written, certified statement that is required for the high technology business investment tax credit. Requires the Director of Taxation and Department of Labor and Industrial Relations to allow the Auditor to access and analyze certain information related to the tax credit.	EDB, FIN
