| HB 1257 | <p>RELATING TO THE PENAL CODE.</p> <p>Amends the offenses of Murder in the First Degree, Murder in the Second Degree, Assault in the Second Degree, and Terroristic Threatening in the First Degree to include conduct committed against victims who the courts and police are attempting to keep safe with protective orders.</p>   | SHS, JUD, FIN |
| HB 1356 | <p>RELATING TO HIGHER EDUCATION BOARD ALLOWANCE FOR FORMER FOSTER YOUTH.</p> <p>Increases the time limit for application for a higher education board allowance form 1 year following high school graduation through the age of 21 years old, to provide former foster youth who are between the ages of 22 and 26 years on July 1, 2007 and already attending an institution of higher education the opportunity to apply for a higher education board allowance within a year. Increases the maximum age for the benefit from 21 years to 26 years with a maximum benefit length of 60 months.</p> | SHS, HED, FIN |
| HB 722  | <p>RELATING TO COUNTIES.</p> <p>Renders void as against public policy any county ordinance that prohibits a group living facility that provides for health care needs of individuals from being located within any specified distance from another group living facility that does not provide for health care needs of individuals.</p>   | SHS, WLH, JUD |
| HB 1314 | <p>RELATING TO FINANCIAL ABUSE.</p> <p>Requires financial institutions and licensed escrow depositories to report suspected instances of financial abuse directed towards, targeting, or committed against an elder or a dependent adult to a local law enforcement agency.</p>  | SHS, CPC, FIN |
| HB 1844 | <p>RELATING TO LAND ACQUISITION.</p> <p>Appropriates unspecified amount to acquire Kulana Nani apartments from Kamehameha Schools by eminent domain should negotiations be unsuccessful.</p>   | SHS, FIN      |
| HB 1762 | <p>RELATING TO PUBLIC HOUSING.</p> <p>Allows the Hawaii Public Housing Authority (HPHA) to work with nonprofit organizations to repair and renovate public housing projects. Authorizes HPHA to collaborate with the Department of Public Safety to allow skilled prisoners perform repairs on public housing projects.</p>  | SHS, FIN      |
| HB 1536 | <p>RELATING TO PUBLIC HOUSING.</p> <p>Places a one year moratorium on the demotion of state public housing. Requires the Hawaii Public Housing Authority to submit a report to the Legislature.</p>  | SHS, FIN      |
| HB 1906 | <p>RELATING TO HOUSING.</p> <p>Transfers administration of section 8 rental housing program from the State to the counties.</p>  | SHS, FIN      |



| HB 487  | RELATING TO HOUSING PROGRAMS.<br>Makes technical amendments to a variety of state laws to implement recommendations of legislative reference bureau report to legislature pursuant to section 14 of Act 180, Session Laws of Hawaii 2006 concerning references that should be substituted in place of references to the housing and community development corporation that was repealed by Act 180. | HSH, FIN      |
| HB 1557 | RELATING TO AFFORDABLE HOUSING.<br>Provides exemptions and waivers for condominiums developments of 50 units or more per acre of land.  | HSH, WLH      |
| HB 1892 | RELATING TO HOUSING.<br>Requires petitioners for reclassification of district boundaries and developers of 25 or more housing units provide for at least 60% of the units to be affordable housing.   | HSH, WLH      |
| HB 926  | RELATING TO COMMUNITY LAND TRUSTS.<br>Establishes a definition of "community land trust" (CLT). Allows CLTs to qualify for Rental Housing Trust Fund moneys, grants, and other state subsidies and funds.   | HSH, WLH, FIN |
| HB 1846 | RELATING TO CONSTRUCTION DEFECTS.<br>Specifies the rights and requirements of a homeowner to bring an action for construction defects, including applicable standards for home construction, the statute of limitations, the burden of proof, the damages recoverable, a detailed prelitigation procedure, and the obligations of the homeowner.  | HSH, CPC, JUD |
| HB 1283 | RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.<br>Allows the HCDA to sell a fee simple interest in reserved housing units.   | HSH, WLH, FIN |
| HB 1908 | RELATING TO TAXATION.<br>Authorizes a tax credit for residential renters within the boundaries of a county if the county agrees to pay the State for the tax loss and administrative cost.  | HSH, FIN      |
