HB 104	RELATING TO HEALTH. Amends Medicaid fee schedule law to require an annual adjustment for inflation. Appropriates funds to retroactively adjust for inflation, payments made to fee-for-service providers for fiscal year 2001-2002 and bienniums 2002-2005 and 2005-2007. Changes Medicaid fee schedule to 100% of the 2006 Medicare fee schedule.	HSH/HLT, FIN
HB 360	RELATING TO MEDICAID. Increases the rates or reimbursement of individual practitioners providing Medicaid services. Appropriates funds.	HSH/HLT, FIN
HB 1363	RELATING TO CRIMINAL TRESPASS IN THE SECOND DEGREE. Makes criminal trespass in the second degree applicable to public housing projects administered by the Hawaii Public Housing Authority.	HSH, JUD


