HB 201 (HSCR1086)	RELATING TO STATE VETERANS' HOME. Establishes a veterans' home account and veterans' gift account to be administered by the Hawaii health systems corporation for the state veterans' home in Hilo. Also requires accounts to comply with reporting requirements for non-general fund information.	IGM/HTH, WAM
HB 1452 HD1 (HSCR1048)	RELATING TO HEALTH. Requires the Department of Health to take soil samples within 500 meters of all military bases in Hawaii to assess for depleted uranium, at least once every 3 months, and annually report to the legislature. Requires air and water samples for the same purpose. (HB1452 HD1)	IGM/HTH, WAM
SCR 58 / SR 34	URGING THE CIVIL DEFENSE DIVISION OF THE STATE DEPARTMENT OF DEFENSE TO DESIGNATE A LEAD STAFF TO ADDRESS THE NEEDS OF INDIVIDUALS WITH DISABILITIES AND SPECIAL HEALTH NEEDS.	IGM/HTH


