DECISION MAKING ON THE FOLLOWING RESOLUTIONS HEARD ON APRIL 5, 2007:

HCR 213 REQUESTING THE UNITED STATES DEPARTMENT OF PSM
DEFENSE TO ALLOW MEMBERS OF THE NATIONAL GUARD
AND RESERVES WHO ARE STILL RECOVERING FROM
ILLNESSES OR INJURIES INCURRED IN THE LINE OF DUTY
WHILE MOBILIZED FOR DEPLOYMENT TO IRAQ OR
AFGHANISTAN, AND WHO HAVE EITHER BEEN
DISCHARGED FOR MEDICAL REASONS OR RELEASED FROM
ACTIVE DUTY TO THEIR RESERVE COMPONENT UNITS, TO
CONTINUE TO HAVE ACCESS TO DEPARTMENT OF DEFENSE
MEDICAL FACILITIES ON THE SAME BASIS AS ACTIVE DUTY
SERVICE MEMBERS, OR TO RECEIVE TRICARE COVERAGE
ON THE SAME BASIS AS RETIREES.

(PROPOSED HD 1) REPORT TO THE LEGISLATURE ON THE FINANCIAL
REQUIREMENTS OF TRANSPORTING, HOUSING, AND ANY

ADMINISTRATION OF SENDING HAWAII INMATES TO OUT-
OF-STATE CORRECTIONAL FACILITIES.


