
HB 282	RELATING TO THE ALOHA STADIUM. Authorizes: (1) disposition of Aloha stadium and surrounding lands that are part of the stadium; (2) acquisition of land in Ewa plains or central Oahu upon which a new stadium may be built.	TAC, WLH, FIN
HB 1230	RELATING TO SALARIES. Establishes a salary for the Aloha Stadium Manager that is equivalent to the deputy comptroller's range.	TAC, LAB, FIN
