b. By Fax: Testimony may also be faxed if less than 5 pages in length, to the Senate Sergeant-At-Arms Office at 586-6659 or 1-800-586-6659 (toll free for neighbor islands). Please indicate that 25 copies are needed.



Testimony received less than 24 hours prior to the hearing will be stamped "LATE."
